•	Guest Speakers: Dawnya Underwood – HOPE Campus Diretor
•	The renovations on the HOPE Campus will hopefully be complete October 31st. There will be six units. They will then engage in licensing the beds soon. They should be able to house between 50-55 youth with both open residential and intensive therapeutic beds available. There should be eighteen beds for emergencies (T-Suites). Ideally the length of stay will be around thirty days for T-Suits, three to six months for intensive therapeutic treatment, and six to nine months for open residential beds. Hopefully sometime in November they will begin renovations on the Welcome Center. Hopefully it will be ready to accept families in the fall of 2026. They are launching a Youth Advisory Council. It will be in partnership with A Place for Me.



Director's Report – Jacqueline Fletcher
 Jacqueline Fletcher thanked Dawnya Underwood for her update on the HOPE Campus. She updated the Advisory Board on the looming cuts to Medicaid that will impact DCFS. She informed the board that the DCY Placement Team is expanding their regional support. She updated the board that over 400 cases have been referred to the Child Protection Team. In 2025 there have been about 115 cases. Rachel Benders will present information about the Child Wellness Summit to the ADAMHS Board. It will potentially be a tight budget cycle for DCFS. DCFS must fund their mandates first. She stated Karen Stormann's unit provides family supports to help with prevention. Kara Davis will attend the meeting in October and provide the director's report update.

Subcommittees
 Intervention – David Crampton – The next Dashboard will be presented at the October meeting. Governance – Angela Newman-White – Eight of the ten board members appointments will be expiring in 2027. The Governance Committee is seeking names of possible new members to continue the work that has been started. Prevention – Gabriella Celeste – The committee met and discussed the HOPE Center. The next Prevention Committee meeting is October 3rd.
