Grant Awardee projects are currently underway, and some initial payments have already been disbursed. Each awardee organization will be asked to complete a fiscal and outcome review to be done every 6 months for the duration of the grant award.

Sarah also distributed to members an infographic of the Region 3 2024 Regional Grant Cycle Report which includes a detailed funding summary of the awarded projects from the 2024 grant cycle. Sarah informed members that a Grant Cycle for each region will be available on the Foundation's website soon.

Several board members had questions for Sarah regarding when the next funding cycle will take place and what the expectations of the timeline will be. Sarah answered that at this time, the Foundation has not yet decided but ongoing discussions are taking place with the Foundation Board, and that all regions will be notified once decisions are made.

6. New / Old Business

A discussion of the 2024 grant awardees and distributions took place between members during the briefing from Sarah Anstine. There was also some discussion regarding what the current state of the opioid crisis in Region 3 was at this time, and it was decided that for all upcoming meetings, there will be information provided to board members regarding the current trends, data, and stats as it relates to the opioid crisis within our region.
