1. Call to order

3. Voting Items

a. Approval of minutes – 3/5/25 Meeting *(Chair Mayor Nicole Dailey Jones)*

a. Presentation of current opioid trends & data *(Cuyahoga County Medical Examiner Dr. Thomas Gilson)*

b. Brief presentation of proposed updates/changes to State law & effects on local service landscape (Mental Health & Addiction Advocacy Coalition – Joan Englund)

Joan Englund led discussion with attendees regarding proposed state-level funding changes and how it may affect local agencies and services. The current bill working through the Ohio legislative session involves proposed cuts/adjustments over the next 2 years for the Department of Mental Health and Addiction Services – noted specific reductions for the 988 Crisis line as well as to Project Dawn. There are also potential changes to Medicaid Expansion, but that is dependent upon changes to the Federal assistance provided for this.

6. Update from the OneOhio Recovery Foundation (*Region 3 Representative Judge David Matia & OneOhio Foundation Director of Partnership and Outreach Sarah Anstine*)

a. Review of Regional Board Volunteer Toolkit

The toolkit is based on a previous version that has been updated to reflect organizational milestones and was informed by surveys from the previous funding cycle. This new version includes new guidance and best practices in several key areas to help better inform and assist each region for the next upcoming grant cycle. Some of these areas include best practices on Region bylaws as well as conflict of interest guidance, among other topics. There is also a tool being developed to support Regions to identify community needs and establish funding priorities.

b. General Updates from OneOhio Recovery Foundation

The Foundation has recently held a strategic planning meeting, but at this time there is no definite timeline for the next funding cycle to share with the Regions. Sarah Anstine also added that organizations who received grant awards from the previous cycle are to report information on their projects to the Foundation every 6 months, and the next reports are due in July. This information will be compiled and organized by the Foundation and then will be shared with each respective Region Board.
