Office of Homeless Services requesting approval of an amendment to a master contract with various US Department of Housing & Urban Development-approved providers for Shelter and Rapid Rehousing for Families. This is the first amendment, adding funds in the amount of \$500,000.00 and extending the term to 5/31/24.

This service is not new to the county:

Prior Resolution Number: R2023-0017, approved 1/24/23

Family Promise offers emergency shelter for families with a focus on youth parenting families, services to link families with rapid rehousing, employment, and other needed resources for self-sufficiency.

Journey Center offers emergency shelter with Rapid Rehousing assistance for survivors of domestic violence, and other related services.

Salvation Army provides emergency shelter with rapid rehousing assistance for homeless families, linkages to employment and housing resources, counseling as requested for trauma, behavioral health concerns, and children's services.

West Side Catholic Center (WSCC) provides emergency shelter and rapid rehousing assistance to single women and families who are homeless due to domestic violence, chemical dependency, economic hardship, or mental health issues.

The anticipated start-completion dates are 6/1/2023 - 5/31/2024.

The primary goals of the project are:

- Provide safe, decent shelter for families facing homelessness and/or domestic violence.
- Move families from homelessness into permanent housing as quickly as possible using Rapid Rehousing assistance.
- Link families with ongoing community supports to ensure housing stability.

Procurement

This contract will be awarded using a Subgrant Agreement RFP exemption.

The four providers were identified as subgrantees through a competitive process completed in November 2021. The Office of Homeless Services, as the lead agency for the Cuyahoga County Continuum of Care, submitted an application to the FY2021 US Department of Housing and Urban Development Continuum of Care Program Competition. OHS is required by HUD to solicit applications for all CoC services and evaluate all proposals competitively through a Review and Ranking Committee. The final review and ranking must be approved by the OHS Advisory Board, the governing body of the Homeless Continuum of Care. A total of four agencies submitted proposals for shelter and rapid rehousing services and all four were recommended for funding.

These providers were also included in the review, ranking, and application for the HUD FY2022 Continuum of Care Competition. OHS was awarded \$494,088 for these projects but has not yet received a grant agreement.

C. - Exemptions

BC2023-403

The Cuyahoga County ("County") Code requires that all contractors doing more than \$10,000.00 in business with the County in a calendar year register with the Cuyahoga County Agency of Inspector General (the "AIG"). If contractors meet certain limited criteria, they may be exempted from the registration process.

County Code Section 501.19(E) provides five (5) exemptions:

- 1) Political subdivisions, public utilities, and other governmental entities.
- 2) Persons or entities that receive either direct payments or reimbursements from the County for the emergency purchase of items required to serve basic needs, including, but not limited to, temporary foster care providers and grocery or department stores that accept vouchers for basic needs.
- 3) Court reporters or expert witnesses in connection with civil litigation or criminal prosecution.
- 4) Persons or entities that receive County funds through a County-sponsored rebate program, including, but not limited to, the County Storefront Renovation Rebate Program.
- 5) Accrediting bodies.

According to Cuyahoga County Code Section 501.19(F), the Inspector General may grant additional exemptions from the registration and/or training requirements of this Section with the approval of the BOC.

The Inspector General is requesting the BOC to renew and approve the following additional exemptions² which shall remain in effect until revoked by either the AIG or BOC:

- 1) Contractors supplying products or services relating to purchases made pursuant to Section 501.03(A) of the County Code ("Emergency and Unforeseen Time Sensitive Mission Critical Purchases") or Section 501.08(A) of the County Code ("County Executive Emergency Authority").
- 2) Borrowers on homeowner rehabilitation loans issued by the Department of Housing and Community Development.
- 3) Borrowers on federally funded housing development loans issued by the Department of Housing and Community Development.
- 4) Physicians that provide medical treatment or services for the County.
- 5) Professional Associations that provide memberships or certifications to County departments, officials and employees (e.g., County Commissioners Association of Ohio).
- 6) Guardian ad litem and assigned counsel providing services to Cuyahoga County Courts.
- 7) Landowners pursuant to federally or state mandated compliance regarding environmental impacts, inspection, remediation or mitigation.

- 8) Landowners pursuant to federally or state mandated compliance or collaboration regarding inspections, rights of way, rights of entry and related activities associated with railways, transportation infrastructure or public utilities.
- 9) Arbitrators and mediators including but not limited to individuals who perform labor and employment dispute resolution services on behalf of the County and various unions who represent County employees.

Additionally, the Inspector General is requesting the BOC to approve the following two new exemptions³ which shall remain in effect until revoked by either the AIG or BOC:

- Daycare/childcare providers providing such services to children who are both in the custody of the Cuyahoga County Division of Children and Family Services and residing with foster or kinship placements.
- 2) Foster parents of children in the custody of the Cuyahoga County Division of Children and Family Services.

Anticipated start-completion dates: July 1, 2023 to June 30, 2025.

The agreement is associated with the release of \$4,500,000.00 in grant funds from the Targeted Community Alternatives to Prison (TCAP) Program from the Ohio Department of Rehabilitation and Correction, Division of Parole and Community Services, Bureau of Community Sanctions. The grant funds are used to divert the number of persons detained by local correction agencies. The funds support programs including but not limited to:

- Personnel costs
- Probation and Community Control programs and services
- Augmentation of Electronic Monitoring Services
- Contracting for residential or outpatient mental health and substance abuse treatment services
- Efforts and/or programs to reduce Cuyahoga County Jail population

The T-CAP Target Population associated with this grant includes fifth-degree felony offenders (F-5) who are prohibited from serving a prison sentence in an Ohio prison on or after July 1, 2018, as outlined in ORC § 2929.34 (B)(3)(c).

Anticipated start-completion dates: July 1, 2023 to June 30, 2025.

CCA Goal: Divert defendants/offenders associated with the Cuyahoga County Common Pleas Court into community-based supervision to benefit the offender, the criminal justice system and the public by providing a more cost-effective sanction than jail or prison, a chance for behavior change and a safer community.

T-CAP Goal: Provide funds to local communities to effectively supervise, provide treatment services and hold accountable low-level, non-violent offenders in the community and at the same time reduce Ohio's prison population.

Funding

The project is expected to be funded 100% by Community Corrections Act (CCA) funds.

The Ohio Department of Rehabilitation and Correction awards \$12,681,032.00 in Community Corrections Act funds for the Court programs identified in Item 1(A) above.

The Ohio Department of Rehabilitation and Correction awards \$4,500,000.00 in Community Corrections Act / Targeted Community Alternatives to Prison funds for the Court programs identified in Item 1(A) above.

The payments will be paid in eight installments, which will be sent by electronic funds transfer during the first month of each quarter of the Grantor's fiscal year until all funds have been expended. Four payments will be expended between 07/01/2023 - 06/30/2024 and four payments will be expended between 07/01/2024 - 06/30/2025.

Item No. 3

The Cuyahoga County Medical Examiner (CCMEO) and its Regional Forensic Science Laboratory is making application for competitively selected federal grant funding under the "BJA FY 2023 Competitive DNA Capacity Enhancement for Backlog Reduction (CEBR) Program" solicitation to enhance its DNA extraction capacity and reduce DNA casework backlogs through the procurement of new additional technology equipment instrumentation, technology operating platform(s) and related consumable supplies. Recent advancements in technology equipment instrumentation and technology operating platform(s) offer higher laboratory flexibility to meet increased demands by law enforcement agencies to process an increase in DNA casework. Grant funding is proposed at a total cost of approximately \$353,308.00 to increase the capacity and throughput of casework while reducing the backlog of DNA forensic testing and analysis for the Cuyahoga County Regional Forensic Science Laboratory (CCRFSL). This is a new federal grant award funding program initiative, as such, there is no prior Board of Control (BOC) history of authority to apply approval(s).

Receipt of grant award funding, with no local match requirement, is to increase the capacity of the CCMEO Regional Forensic Science Laboratory which is the primary accredited DNA Analysis Laboratory for Cuyahoga County and the region. Funding will improve the quality and timeliness of forensic DNA testing services. These improvements are critical to preventing future backlogs and to helping the criminal justice system use the full potential of newly available DNA technology. The authority to apply for funding will ultimately provide the CCMEO with the support needed for safer public health and safety for the communities served by the CCMEO. The grant's period of performance is projected for the period 10/1/2023 through 9/30/2025.

The Cuyahoga County Regional Forensic Science Laboratory (CCRFSL) has limited funds to address the increased costs of casework and acquiring the budgeted total of approximately \$353,308.00 in funds is critical in building capacity and reducing backlog of casework to benefit law enforcement prosecution of crime and increase the safety for the citizens the CCMEO/CCRFSL serves. The funding requests new technology equipment instrumentation, software and consumable supplies to enhance the DNA extraction capacity and reduce DNA casework backlogs.

The project will address capacity enhancement and backlog reduction by procurement of DNA new technology equipment instrumentation, software platform(s) and consumable supplies that will align with regulatory and accreditation requirements.

The procurement method for this project is through acceptance of an approximately \$353,308.00 grant agreement from the U.S. Dept. of Justice (DOJ). The procurement of DNA consumable supplies and staff training conference attendance at one DOJ Award recipient conference and one to maintain DNA continuing education and accreditation requirements. All procurement will be in accordance with Cuyahoga County policies and standards while maintaining compliance to Federal procedures and compliance as required and pursuant to award acceptance.

Contractor and Project Information

The grant funds will be used for new technology equipment instrumentation, along with related software platform(s) and consumable supplies for the Cuyahoga County Regional Forensic Science Laboratory to enhance the DNA extraction capacity, throughput and to reduce DNA casework backlogs.

Project Status and Planning

Based on award receipt the project is projected to begin on 10/1/2023 and end on 9/30/2025. The project is for competitively selected funding to enhance the operations of the Cuyahoga County Regional Forensic Science Laboratory.

Funding

The project is 100% grant funded. The schedule of payments received by Cuyahoga County is through quarterly reimbursement requests on costs incurred during the Award's period of performance and as submitted to the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance.

The Cuyahoga County Medical Examiner's Office is seeking approximately \$396,006.00 in grant award funding with no local match requirement to increase the capacity of its Regional Forensic Science Laboratory which is the primary accredited DNA Analysis Laboratory for Cuyahoga County and the region. The award will provide the DNA laboratory grant funding to process more DNA samples to reduce the number of forensic DNA samples awaiting analysis and/or prevent a backlog of forensic DNA samples. The grant's period of performance is projected for the period 10/1/2023 through 9/30/2025.

The Cuyahoga County Medical Examiner's Office Regional Forensic Science Laboratory (CCRFSL) has limited funds to address the increased costs of casework and acquiring the budgeted total of approximately \$396,006.00 in funds is critical in building capacity and reducing backlog of casework to benefit law enforcement prosecution of crime and increase the safety for the citizens the CCRFSL serves. The majority of funding has been allocated to DNA forensic casework for consumable supplies. The budget allocation includes CCRFSL DNA staff attendance at two training events to maintain continuing education and accreditation requirements.

The project will address capacity enhancement and backlog reduction by procurement of DNA supplies and staff training conference attendance to maintain award receipt requirements and DNA continuing education and accreditation requirements.

Procurement

The procurement method for this project is through acceptance of an approximately \$396,006.00 grant agreement from the U.S. Dept. of Justice (DOJ). The procurement of DNA consumable supplies and staff training conference attendance at one DOJ Award recipient conference and one to maintain DNA continuing education and accreditation requirements. All selected travel required trainings will be in accordance with Cuyahoga County procurement policies, standards, and rates, while maintaining compliance with the U.S. General Services Administration (GSA) per diem standards and rates as required and pursuant to award acceptance.

Contractor and Project Information

The grant funds will be used for staff attendance at one mandatory DOJ Award recipient conference, and one mandatory conference for human identification training to maintain laboratory accreditation and licensing, and; to procure highly technical scientific consumable supplies to process DNA casework at the Cuyahoga County Medical Examiner's Office Regional Forensic Science Laboratory.

Project Status and Planning

Based on award receipt the project is projected to begin on 10/1/2023 and end on 9/30/2025. The project reoccurs annually, and funding is based on a national formula equation that establishes financial assistance funding to states and local governments. The funding formula algorithm is based on local and national Federal Bureau of Investigation (FBI) violent crime statistics.

Funding

The project is 100% grant funded. The schedule of payments received by Cuyahoga County is through quarterly reimbursement requests on costs incurred during the Award's period of performance and as submitted to the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance.
