# 4. MAIN CCESAB MEETING REVIEW

- Kevin Friis stated the URL for Knowledge Center will be discontinued. He also stated
  that there is a swap out for Knowledge Center to the state's web platform. This is free
  for State EMA's.
- There will be a NDMS exercise June 27 through June 28 at the Cleveland V.A. Hospital.
- Steve Greene stated that the CCESAB By-laws were approved.

# 5. GRANTS UPDATE

Steve Greene stated that most UASI grants are fully funded. He also stated that there
was an emergency meeting to address additional funding for LPR in police
departments.

### 7. COUNTY INTEROP TEMPLATE UPDATES

- Brad Handke stated that for zone M-14, the XPTNOPS is not supposed to be in the template. It is someone's talk group that they did not want in the shared template. Kyle Jamison stated that zones M-15, M-18 and M-22 are gone and will be eventually phased out of Inter-Op templates because they are not being used.
- Brad Handke stated that for zone M-17, XMARCS15 and XMARCS16 have been added. In zone M-20, XECOMM29 thru 32 have been added. Definitions for Cleveland have been set as to what each zone is for. There are 28 hospital zones in Cuyahoga County, but only 16 slots are available. It comes down to what zones will be added and what zones will be removed.

### 8. EXERCISES/DRILLS FOR COM-L PARTICIPATION

• Kevin Friis stated that there will be a full-scale regional drop site exercise in October. He also stated that this will be a statewide drill regarding Anthrax release attack.
