MINUTES

- CALL TO ORDER
 - Meeting was called to order at 9:015 AM
 - Roll Call conducted; quorum met

• APPROVAL OF MINUTES

• F. Szabo motioned to approve the minutes from the 11/22/22 meeting. J. Corn seconded. All yeas, no nays. Minutes approved.

• PUBLIC COMMENT

• GRANTS UPDATE

- M. Christie provided an overview of the three FY23 UASI grant requests for the committee's review: CSU's cybersecurity project, Emergency Management's exercise project, and MetroHealth's ballistic-resistant film project.
- W. Helou and A. Mansoor from the CSU IT Department discussed their request for \$500,000 to procure 24/7 IT monitoring services that would protect CSU from cyber and ransomware attacks. W. Helou discussed how the services they are seeking are distinct from what they currently receive from the MS-ISAC. Additionally, A. Mansoor discussed how the project would not only benefit CSU, but also the Northeast Ohio Cyber Consortium.
- M. Owca reviewed MetroHealth's request for \$144,103.96 to procure/install ballistic-resistant film on the ground-level windows at the newly built Glick facility.
- M. Christie discussed Emergency Management's request for \$80,000 to pay for the overtime and backfill of participants and materials for two mass casualty exercises.
- After a brief Q & A on the projects, M. Christie asked for a motion to recommend prioritization of them. J. Corn. made a motion to prioritize the Emergency Management exercise project first, MetroHealth's ballistic-resistant film project second, and CSU's cybersecurity project third. M. Christie asked if there was any discussion on this prioritization. Chief Pettrey requested insight into J. Corn's reasoning. After a brief discussion among committee members, B. Horwatt seconded the motion. All yeas, no nays.

¹ **EXECUTIVE SESSION MAY BE HELD PURSUANT TO OHIO REVISED CODE (ORC) 121.22(G)** ORC 121.22(G)(5), a public body may hold an executive session to consider "matters required to be kept confidential by federal law or regulations or state statues." ORC 121.22(G)(6) provides that consideration of "[d]etails relative to the security arrangements and emergency response protocols for a public body or a public office, if disclosure of the matters discussed could reasonably be expected to jeopardize the security arrangements and emergency response protocols for a public office." Under this exception, both conditions must be met: (1) the subject of the meeting must relate to the security arrangements and emergency response protocols for a public body or a public office; a(2) public disclosure of the matters discussed could reasonably be expected to jeopardize the security of that public body or public office.
