Data Warehouse

a. Mobile Trailer's

Nick Diccio stated that all is going well with Tyler Technologies. Currently waiting for the Interface. Nothing to do until they push data for DW to elevate. The status for the Mobile Cameras and Trailers is still the same. All are in use daily. The four extra trailers are helping tremendously. The latest stats-228,000,000 plates in the LPR, average on a weekday is 1.3 million reads a day. The Jewish Federation is averaging 15,000 reads a day.

b. Phase III LPR's

Sgt Devlin is working with PS&JS. They should have all specs to put out for bid. At this time we are waiting to hear from the cities that put in a request to find out if they have fiber optics at an intersection.

We are looking to switch to fiber optics from cellular to lower cost. Depending on the vendor's prices, we are looking at eight to ten intersections for Phase III.
