The plan to extend the current contracts by amending them is the only way to assure that this critical community services is maintained, and that the providers are authorized to provide the services and be compensated for these services.

F. Provide an explanation of unacceptable delays in fulfilling the County's need that would be incurred if award was made through a competitive bid.

Without the contract amendments for funds and time, the providers will not be authorized to continue providing the basic emergency shelter services for over 500 single adults/ night. The agencies will have to lay off staff and close the shelters.

G. Describe what future plans, if any, the County can take to permit competition before any subsequent purchases of the required supplies or services.

The County is in the process of conducting an RFP process which will identify provider(s) to continue emergency shelter services for single homeless adults. The term of the RFP is 3 years. The RFP will not be required to be reissued until FY 2014. At that time, we will begin the RFP process in June, in order to complete the award prior to the start of the new contract period.

BC2011-148 Agency of the Inspector General Department(s) impacted: Workforce Development

Description of exemption request: Department of Workforce Development requesting exemption from ethics training and registration for all On-the-Job Training Program ("OJT Program") Contractors.

Reasoning: The OJT Program reimburses employers up to 50% of the hourly wage of an unemployed/displaced employee while the employee is provided occupational skils training in a new job. The OJT Program is funded entirely by Federal dollars issued pursuant to Section 663.700 of the Workforce Investment Act. The "contractors" under the OJT Program are employers that have agreed to hire unemployed or displaced workers in exchange for the wage supplements during the training period. Wage supplements are capped \$5,000 per employee (average payment is approximately \$2,000). Contractors/Employers are recruited by the Department of Workforce Development to participate in the program (i.e., Contractors/Employers do not typically solicit the Department to participate). Employer/Contractors are required to meet Federal requirements for participation in the program. The Department has already received an exemption from the procurement process for this program.

Requiring the Contractors/Employers to submit to ethics training and registration may have a chilling effect on program participation, thus limiting placement options for the Department.

Description of exemption request: Borrowers on development loans (homeowner rehabilitation, housing development, small business, and brownfield loans) issued by the Department of Development.

Reasoning: The Department of Development issues loans in four general areas - 1) homeowner rehabilitation; 2) housing development; 3) small business; and 4) brownfields. Depending on the nature of the project, these loans are funded with federal, state and/or general fund dollars. Borrowers are required to complete an application process and meet specified criteria for approval. Applications are approved by outside review committees (Jumpstart Review Committee, Community Improvement Corporation, and/or Housing Review Committee). The loan applications undergo a full underwriting process conducted by the Department of Development. The primary benefit of the program to Borrowers is the less stringent approval requirements associated with the Development loans. This gapfinancing allows for more low-income individuals or non-traditional companies to secure financing for development, create jobs, and leverage private sector investment. Public financing exists to supplement private financing in order to increase the number of credit worthy development projects receiving the necessary funds to proceed. Repayment performance has been historically strong for all loan programs. Because these agreements are loan agreements and undergo a full underwriting process, it is the opinion of the Department and of the Inspector General that the Borrowers under these programs should be exempt from the training and registration requirements under the ethics ordinance.

Reasoning: Ohio law requires applicants for medical licensure to demonstrate good moral character as identified through a rigorous assessment and background verification procedure. Each licensee is required to meet rigorous ethical standards of practice as determined by appropriate professional associations or accrediting bodies. The use of physicians and hospitals by the jail for inmates is dictated by the medical circumstances of the patient as determined on a case by case basis. The cost of all medical treatment provided to inmates is statutorily set at Medicaid Rates. Human Resources selects fitness for duty physicians on a rotating basis depending on the particular speciality that is applicable to the employee situation and the speed with which the physician can schedule the appointment. The Medical Examiner periodically contracts with physicians for expert opinions and testimony if necessary.
