1) CALL TO ORDER

Chief Public Defender Tobik expressed concern regarding the Public Defendersøoffice inclusion in the proposed salary study, in particular the supervisors in his office. Public Defenders George and Haller expressed concerns as to whether the limited focus of the study on the Prosecutorø office would impact the attorneys in the Public Defenderø office. Chairman Wolff noted that while the attorneys in the Public Defenderø office address salary issues through the collective bargaining process, the HRC will communicate to Council that the Public Defender bargaining unit attorney positions are currently linked to pay grades in the Prosecutorø salary structure through previous studies by the Archer company and that it is the HRCø expectation that any findings from the study of the Prosecutorø office will be without prejudice to the bargaining rights of the Public Defenders or the rights guaranteed that bargaining unit under Chapter 4117 of the Ohio Revised Code..
 - ii) Hearing Officer contracting Administrator Kopcienski stated that the process of contracting with Ms. Tsevdos to serve as a Hearing Officer is underway.
- b) Charter Amendment Request to Council Discussion ensued. Administrator Kopcienski to invite County Councilwoman Conwell to attend the April 18th HRC meeting.
