# RADIO PROGRAMMING SUB-COMMITTEE REPORT

- The sub-committee looked at 16 talkgroups that MARCS gave and find them useful and will maintain the MTAC talkgroups. As 3.5 fades away we will move to just XMTAC. MTAC are only in Cuyahoga County radios while CUYCO talkgroups are also in surrounding county's radios
- Common zone naming will be forthcoming to make it easier for responders to find interoperable talkgroups.
- CECOMS will be the one place for monitoring and requesting channels. CECOMS will monitor CUYCO-1, MTAC-1 and XMTAC-1.

## **RADIO REQUESTS UPDATE**

  - When they will be put to use
