2. What is the product/service that you seek to acquire?

The Cuyahoga County Sheriff is seeking a system upgrade agreement with Intellitech Corporation for our Jail Management System to go from IMACS to IMACS V. IMACS is the system used by our Corrections Center to book and release inmates, track property and clothing, schedule visits, handle commissary, and a host of other jail functions.

3. Will this purchase obligate Cuyahoga County to this or any other vendor for future purchases, for example, maintenance, licensing or continuing need? X Yes D No If yes, please provide details regarding future obligations and/or needs.

This purchase will obligate Cuyahoga County to this vendor for future purchases because their software is a licensed product. License and support agreements would be needed as long as the system is in use.

4. Why do you need to acquire these goods or services?

Our current version of IMACS is 10 years old and will no longer be supported by the vendor after 2013. IMACS currently is one of the core, mission critical applications of the Corrections Center.

5. Why are the requested goods/services the only ones that can satisfy your requirements?

The software is licensed and no other company has permission to provide software support or make changes to their product.

6. Were alternative goods/services evaluated? If yes, what were they and why were they unacceptable? Please be specific with regard to features, characteristics, requirements, capabilities and compatibility. If no, why were alternatives not evaluated?

Provide names of alternate sources that were considered and specific reasons why each one was rejected. If other options were not evaluated, indicate the basis for not considering available alternatives.

Initial examination of two other jail management systems were conducted late last year- Aegis Corrections Management by New World Systems and Offender Management System by DSI-ITI. Due to cost constraints and the impending take-over of Cleveland jails, upgrading to IMACS V was deemed to be the most cost effective, lower risk solution.

7. Identity specific steps taken to negate need for sole source provider.

Until the county has the resources to create and support large, mission critical applications, there will be a need for some sole source license and maintenance agreements with outside vendors. Smaller applications are being handled in-house.

8. Has your department bought these goods/ services in the past? X Yes D No

Intellitech Corporation has been the contractor/supplier of our jail management system since it was implemented in December 2002. Last year's maintenance contract dated January 01, 2012 was for \$106,055.00.

9. What efforts have been made or are being made to reduce the Department's reliance on a sole source provider for these goods/services in the future?

The Cuyahoga County Sheriff does not foresee any short term resolution to our reliance on a sole source provider.

10. What efforts were made to get the best possible price?

No discounts were made available for this contract, but the vendor added 500 licenses to make us compliant and to cover the acquisition of Cleveland. Value added for the additional licenses is \$150,000.00.

11. Why is the price for this purchase considered to be fair and reasonable?

Indicate any price comparisons or other benchmarks against which the vendor's price was evaluated. For example, if a professional service, are the hourly rates comparable to those available for providers of similar services? If no price comparisons were made, please explain.

The price is fair and reasonable because this is a major upgrade and associated costs for a new system is six times as much.

The Division of Children and Family Services is requesting approval of a donation of \$1,800.00 to support the National Council of Jewish Women's Dignity Project. 150 duffle bags have been donated this year. 75 have been distributed. So far this year NCJW has made 6 deliveries of boxes filled with stuffed animals and books, constituting over 250 stuffed animals and approximately 250-300 books. It is estimated that each filled duffle bag has a retail value of approximately \$25-\$28.

The invoice dated October 12, 2012, reflects a time period of July 1, 2012- June 30, 2013 because the Dignity Project's budget is based on the State Fiscal Year.

The National Council of Jewish Women (NCJW) launched Project Dignity approximately 7 years ago to assist youth in DCFS custody. This initiative is coordinated, managed and supported by NCJW's network of volunteers and supporters. NCJW has sole responsibility for the collection and distribution of all donations associated with this initiative.

4. What other available options and/or vendors were evaluated? If none, include the reasons why.

Through the Project Dignity Initiative, NCJW has been providing duffle bags filled with toiletry items, backpacks filled with school supplies, educational books, toys and stuffed animals to children in custody to DCFS since approximately 2005.

5. What ultimately led you to this product or service? Why was the recommended vendor selected?

Project Dignity is one of NCJW community service projects. The initiative benefits youth in foster care by helping to ease their transition from their homes into care.

6. Provide an explanation of unacceptable delays in fulfilling the County's need that would be incurred if award was made through a competitive bid.

This initiative is coordinated, managed and supported 100% by NCJW's network of volunteers and supporters. The items are donated and provided to DCFS at no cost. Any delays may result in the end of this NCJW community service project which directly benefits children in DCFS custody.

7. Describe what future plans, if any, the County can take to permit competition before any subsequent purchases of the required supplies or services.

The physical items are donated and provided to DCFS at no cost. The donation/support of \$1,800.00 to the NCJW is far below the retail price of \$3,750.00- \$4,200.00 to purchase these same items.
