#### **SPAN RADIO REQUESTS**

C. Flynn reported on a letter from SPAN's legal representatives citing the committee defined daily use after the grant request and that they were following the grant guidelines. C. Flynn bringing this to the Committee to for input. Committee stands behind original intention that the radios were for those joining a P25 system for daily/primary use. B. Carney motioned due to the intention of the committee to have users on a P25 system for daily/primary use, the radios should not be awarded to SPAN if SPAN is unwilling to sign the MOU as it currently is written. ### **RADIO REQUEST REVIEW**
