#### 4. SIEC REPRESENTATIVE

 M. Lasky nominated G. Balasko and T. Cramer nominated B. Turner for SIEC representative for the Cuyahoga County/Cleveland UASI region. Vote taken. G. Balasko received the majority of votes. B. Turner may be the alternate. This information will be forwarded to Cuyahoga County.

## 5. CCESAB REALLOCATION

- The Communications Committee received the reallocation for funds in the amount of \$514,614.72 this is in addition to the original reallocation of \$351,103.96. This item is currently scheduled to be heard for the first reading with County Council on March 27, 2013 and then to the Public Safety Committee for review and back to Council on April 9, 2013 for second reading. If requiring an additional reading it will be back on a Council agenda on April 23, 2013. This allows for a purchase of 366 chargers and radios in addition to 152 remaining from the previous order.
- N. DiCicco reported that Warrensville Heights (Southeast request) remains interested in the radios and Gates Mills Police Department (SPAN request) is now interested and willing to sign the MOU. They are planning on moving to the Chagrin Valley Dispatch. Other municipalities have changed their situation and have not been able to revise request or be considered, it was clarified that SPAN's request will remain as is. Should there be additional radios once all those current list is completed it will be brought back to the Communications Committee as to how to handle requests.
