Hearing no further nominations a roll call vote was taken; Commander Harold Pretel unanimously elected Vice-Chair.

5. APPROVAL OF THE MINUTES

Chief Ledford called for a motion to approve the meeting minutes of Dec. 12, 2013; Chief Zemek moved; Beth Gatlin seconded; all in favor; none opposed; minutes approved.

6. OEM ADMINISTRATOR UPDATE

Walter Topp reported on upcoming Office of Emergency Management workshops, LEPC exercise and Ready Cuyahoga. Mark Christie gave a PowerPoint presentation on Threat and Hazard Identification and Risk Assessment (THIRA), processes, next steps and planning workshop.

COMMITTEE REPORTS

AMS - Bob Kollar

Committee met in Jan. reported new NEORAMSS board voting member-MetroParks. Completed rescue training in conjunction with US Coast Guard and Cleveland Fire Dept. for 134 public safety partners; currently 50 certified ice divers in the county; FY2013 Port Security Grant release in March.

<u>Citizen Corps – Sharon Nicastro</u>

Reported FY2011 requests completed. Focus on credentialing all volunteers and the training and exercise plan. FEMA guidance has been issued for CERT and Citizen Corps core capability contribution.

Communications – Chief Flynn

Additional review of Tactical Interoperability Communications Plan (TICP) needed due to changes. County Legal Dept. decision review of radios funded by Dept. of Homeland Security grants and distribution to private entities (hospital, university police) is allowable as they are mutual aid for local law enforcement, although no radios are available at this time. Jerry Mullins clarified the CCESAB would make any final decision with regard to radio distributions.

EMS – Chief Zemek

Committee met Jan. 13; discussion on re-purposing of mass casualty supplies into trauma response bags; update on OHTrac, statewide patient tracking system for mass casualty incident; next meeting March 10, at 2:00 p.m.

Fire - Chief Carroll

Committee will meet in March; on track with spending down grant funds.

Chief Ledford noted for the record Chief Mike Carroll voted in as Chair for the Fire Committee.
