## **Minutes**

Meeting of the Statutory Members of the Cuyahoga County Board of Revision January 13, 2014 at 3:00 PM

Required legal notices were provided and posted. The meeting was held at Courthouse Square, 310 Lakeside Avenue, 7<sup>th</sup> Fl., Cleveland, OH 44115. The meeting was called to order at 3:01 PM by **Matt Carroll**, Chief of Staff, representing Cuyahoga County Executive, Edward FitzGerald, Board Chairman, pursuant to Ohio Revised Code Section 5715.09. The roll was called. Present were:

A Motion was made by **Parks** to accept the nomination of **FitzGerald** as the Board Chairman and seconded by **Greenspan**.

**Dan Harbaugh**, Board of Revision Assistant, presented a request to permit the Board of Revision to hire six (6) 120 day part time employees. A discussion of the nature of work and pay level ensued.

A Motion was made by **Greenspan** to approve the request to permit the Board of Revision to hire six (6) 120 day part time employees and seconded by **Parks**.
