- **1. CALL TO ORDER -** Co-Chairman: Beth Gatlin called the special meeting of the Health & Medical Functional Committee to order, April 29, 2014 @ 1300 at American Red Cross.
- 2. ROLL CALL / QUORUM DETERMINATION- Quorum established
- 3. PUBLIC COMMENT-No public Comment
- **4. DISCUSSION OF THIRA PROCESS BY CCOEM-**Review of Cuyahoga County top THIRA threats and core capabilities for use in deciding/approaching IJ requests. Grants finishing up open grants prior to announcing FY14 funding approvals which will run September 2014 through August 2016.
- 5. DISCUSSION OF FISCAL YEAR 2014 UASI PREFERENCE FOR COUNTY APPLICATION-Discussion regarding request for funding to maintain the Regional Functional Needs Planner position and deliverables expected. Will be supported by the MMRS Healthcare Coalition Functional Needs subcommittee. Motion by Marek Owca to request up to \$20,000 to maintain the Functional Needs Planner position to develop and share an ESF8 Resource Guide, to be housed at EOC, of those agencies with functional and access needs and to sustain, enhance and align the current plans to ensure inclusion of Access and Functional Needs in those

plans. Patrick Cusick seconded. All in favor. None opposed. This will be #1 priority request.

Discussion regarding the request for PAPRs, PAPR filters and PPE kits to replaced expired items for regional distribution. PPE kits are good for 10 years while PAPR filters are good for 3-4 years. Motion made by Mark Myers to request \$150,000 to purchase PAPRS, PAPR Filters and PPE Kits to replace expired items. Tom Cannell seconded. All in favor. None opposed. Public Health supports this purchase for hospitals for disease control and worker safety. This will be #2 priority request.
