Mike Chambers, Department of Public Works, presented. Mike answered questions posed by Dale Miller related to the cost estimate. The estimated cost for this purchase was \$86,000.00.

This project will enable the region to capitalize on those assets. Ed also stated the County is working with partners to make a Public announcement about this project and asked Nate to keep Councilman Miller informed so that he can be a participant in the announcement. Nate also answered questions posed by Dale Miller related to the relationship between NASA and the Airport on the proposed project. Nate replied that the emphasis of this project is on NASA Glenn, and technology transfer from the aerospace industry.

The costs specified for these services are based on the type of home eradication required and range between \$1,000 - \$1,200 for a 1 bedroom unit, and \$1,100 - \$1,600 for a 3 bedroom home.
