#### v. OPEN DISCUSSION

Electronic Monitoring Services Contract: General Division, Juvenile Division, Sheriff's Department. Chairman FitzGerald raised the subject of expanding electronic monitoring services as an option for incarceration. Included in the conversation were cost effectiveness, enforcement, use in municipal court settings and stressed the decision to use the service would be up to the sentencing Judge.

#### VI. NEW BUSINESS

Judge Russo commented on the first meeting with National Center for State Courts regarding the development of a comprehensive early pretrial system (central booking), with preliminary data gathering and assessment. There will be an initial onsite visit in August. Judge Russo noted a visit to Maricopa County in Arizona, with Greg Popovich, to review their judicial system processes, a presentation will be forthcoming.

Chairman FitzGerald reiterated his thoughts on investment and reallocation of surplus funds in the justice system to improve process and services.
