- 4. Cuyahoga County Mass Notification System ReadyNotify Jeff Harraman
  - Mass notification system used by Cuyahoga County and participating municipalities
  - Sends notifications to residents of your community
  - Sends notifications to groups/lists of employees, specialized teams, etc.
  - The public began registering on March 3<sup>rd</sup>.
  - Available to municipalities beginning April, 2014.
  - Free and unlimited for communities

#### 5. EMD Update – Nancy Kolcan

- CECOMS staff completed CPR and will complete PST by end of month
- Identified our Medical Instructor as David Yarmesch from MetroHealth Medical Center
- Participating dispatchers must be CPR certified and have PST certification or equivalent.
- Next steps
  - Confirm departments who wish to participate in the program
  - Identify departments who would like to host a training session
  - Advise each department's medical director of intent to participate in county program and utilize APCO guidecards approved by Dr. Collins.

- 6. OnStar Presentation Sherry LeVegue
  - Ohio has over 24,000 subscribers and is listed in the top 10 of subscriber states nationwide
  - How OnStar Works
    - Customers must have active subscription, cellular connectivity and battery power.
    - OnStar works with GPS satellite signals
    - OnStar advisors receive first contact through call button or emergency activation.
    - OnStar advisors receive GPS coordinates. They will vet calls and determine if Emergency response is needed.
    - ANI/ALI information on your positron will show up as "OnStar" with callback number and latitude/longitude coordinates of vehicle.
    - OnStar advisors are certified in EMD through Priority Dispatch.
    - Call takers will three-way calls with 9-1-1 dispatchers and assist as needed until first responders arrive on scene.
    - Ability to locate stolen vehicles and initiate "slow down" of vehicle.
