A. Tabled Items

B. Scheduled Items

CPB2014-916 Department of Public Works submitting an amendment (Subsidiary No. 2) to Contract No. CE1200700-01 with Perk Company, Inc. for the resurfacing of Rockside Road from Turney Road to Broadway Avenue in the Cities of Bedford, Garfield Heights and Maple Heights for additional funds in the amount not-to-exceed \$14,116.45.
