#### Northeast Ohio Region AMS [NEORAMSS]- Peter D. Killmer, Executive Coordinator

- A) The Chairman for the NEORAMSS, LT Bob Kollar of Cleveland Fire Department, provides his regrets for being unable to provide representation at this meeting. NEORAMSS leadership has a competing meeting today being conducted to address Subcommittee business and planning for a number of upcoming events.
- B) Results for the FY2014 Port Security Grants Program and the list of successful grantees has been published by DHS. NEORAMSS provides that this information is important for CCESAB situational awareness. The following list provides the applicants and projects funded by FEMA:
  - 1) City of Cleveland Public Safety: \$568, 027 (2 projects)
    - a) Funding is provided to address physical security enhancements (e.g., cameras, locks, etc.) for City of Cleveland at three tended high level lift bridges over the Cuyahoga River
    - b) Funding is provided to rehabilitate the fireboat Celebreeze to continue its long history of maritime safety/security/response around the Port of Cleveland
  - 2) Cleveland-Cuyahoga County Port Authority: \$74,250 (1 project)
    - a) Funding is provided to address physical security enhancements at the Port of Cleveland
  - 3) State of Ohio ODNR Division of Watercraft: \$24,750 (3 projects)
    - a) Funding is provided to address operations and maintenance of on-water response boats; enhancements to communications resources and hand held thermal imaging detectors for the boats.
  - 4) Kinder Morgan LLC, Ashtabula, OH: \$57,750 (1 project)
    - a) Funding is provided to address physical security enhancements at facility in the Port of Ashtabula.
- C) A draft update of the Eastern Great Lakes Area Maritime Security Plan [EGL AMSP] is being reviewed along the chain of command by US Coast Guard, as of this writing. Northeast Ohio maritime security issues, for the four county regions (Lorain, Cuyahoga, Lake & Ashtabula) are addressed within this plan. The revised five year plan, required by federal regulations, is expected to be approved in its final form OOA September 2014. The plan can be made available for review by potentially affected port partners with a "need to know" when it becomes effective. The document will be deemed "sensitive security information" as defined by DHS information security policies.
