# d) Pay Equity Study Recommendations

Administrator Kopcienski stated that the PRC has been in engaging in discussions with the interim HR Director, Lisa Durkin, to look at the recommendations that came from the study conducted by the consultant. Administrator Kopcienski proposed that the Commissioners consider several recommendations to consider presenting to the Administration. Interim HR Director Durkin advised she would prefer time to evaluate the recommendations. The Commissioners directed the Administrator to continue discussions with Ms. Durkin. Discussion ensued.

Chairman Colaluca stated the necessity to ensure that Council accepted the recommendations from the study as they determine the County's budget.

### e) PRC Hearing Officer Update

Administrator Kopcienski updated the Commission on the status of the Hearing Officers' current contracts and noted they are scheduled to expire in December 2015. She suggested the Commissioners may want to consider whether Hearing Officers should be employees rather than independent contractors; Commissioner Wolff directed her to prepare an analysis of that alternative. Discussion ensued.
