I. Call To Order/Roll Call

Chairman Norberto Colón called the meeting to order, roll was called, all members in attendance.

II. Approval of Minutes (Nov. 17, 2014)

Chairman Colón moved to approve the minutes of the Nov. 17, 2014 meeting; Michael Gallagher seconded. Minutes approved.

Chairman Colón commented on the future of the 9-1-1 Consolidation Shared Services Fund Committee and the 9-1-1 Consolidation Plan pending the new administration's changes in the plan and fundamentals, as it may be accelerated and countywide Public Safety Answering Points (PSAP's) specifically named.

Review/Approval Eastside Departments Group Enforcement (EDGE)

Chief Nietert, South Euclid Police Dept. and Patrolman Dan Grein gave an overview of EDGE formed in 2011, composed of the cities of Beachwood, Shaker Heights, South Euclid, University Heights and Euclid. Proposed consolidation project now includes all cities except Euclid although they are a member of EDGE. Project now include cities of Cleveland Heights and Pepper Pike. Cities are prepared to match \$200,000.00 in funding for the project at this time.

Questions and answers from the committee noted reduction in PSAP's would be four (4). Location of the dispatch center would be Beachwood Police Dept. Project allows for ten (10) workstations with capacity for five (5) additional stations.

Review/Approval City of Parma

Mayor Timothy DeGeeter and Shelley Cullins spoke on behalf of their application in partnership with the cities of Parma Heights and Brooklyn. Dispatch center would serve 120,000 residents, to be located in Parma with growth potential to include additional municipalities. Center would be operational by July 2015.

V. Old Business

Chagrin Valley Dispatch Center (CVDC)

Lt. Nick DiCicco gave an overview of Chagrin Valley's first request and municipal PSAP consolidations; update on the dispatch center to date. Review of second request for funding which was denied. Discussion and comment were made regarding the application process, rules and audit process; requesting reconsideration of the application for \$366,500 to support addition of City of Euclid.
