Section 501.12 (d) provides for the exemption from competitive bidding when approved by the Board. In previous bids Boyas was usually the only respondent. Additionally, Boyas is located directly across from the Sanitary Facility on Canal Road in Cuyahoga County where as other EPA sites are located in Summit County and Lorain County and would require considerable travel time and loss of productivity. Additionally, Boyas has been the lowest price and only respondent due to location restrictions.

6. What other available options and/or vendors were evaluated? If none, include the reasons why.

This is the best option for the County. There are a limited number of EPA approved dump sites that can be used within reasonable travel time. The other sites are located in Summit and Lorain Counties and would require considerable travel time to the dump sites. The additional travel time which can be substantive will decrease productivity within our communities and cause a negative impact financially. Approval of this request will allow the County the greatest flexibility and cost savings.

7. What ultimately led you to this product or service? Why was the recommended vendor selected?

		The County is required to dispose of sewer and storm debris at an EPA approved facility and Boyas is located near the Sanitary Facility. In addition, consideration was given to travel time and lost productivity by incorporating other solutions.

Cuyahoga Health Access Partnership (CHAP) is a stand-alone non-profit organization incorporated in Ohio. CHAP's founding partners are key stakeholders in the health of Cuyahoga County residents, including local government, hospital systems, free clinics, federally qualified health centers (FQHCs), providers, health plans and local foundations. This public-private partnership developed a streamlined system of access in advance of Medicaid Expansion and now serves as one of the lead navigator entities in Cuyahoga County and the convener of the Northeast Ohio Outreach & Enrollment Council.

As a sub-grantee of the Ohio Association of Foodbanks, CHAP will serve as a federal navigator entity along with 9 other organizations throughout the State of Ohio. (Asian Services in Action, Inc. is the only other grantee in our region, but with a specialized focus on the Asian and Pacific Islander population.) The amount of education needed in the community and assistance with connecting residents to the correct resources is critical.

CHAP will continue to serve Cuyahoga County's interest by through several established areas of work while developing a new program to meet the needs of the newly insured consumers in Cuyahoga County.

Access Plan – CHAP will maintain the web-based eligibility Access Plan at provider locations for consumers that do not qualify for Medicaid or assistance on the Health Insurance Marketplace and need access to primary and specialty care.

Navigation Services – Educate, counsel, and enroll qualifying adults in health coverage in Cuyahoga County with a particular focus on the County's Justice Center population.

REF 111 - Amended agreement No. 1 contained an error in which \$89, 961.50 was accidentally decreased which should not have been. This item is returning the amount accidentally reduced back in to the contract. It is not associated with any work items.

REF 112 - The Cities of Richmond Heights and Euclid requested that sharrows be added to the project. The request was forwarded to ODOT, and ODOT agreed that the sharrows could be added and were eligible for federal funds.

REF 113 - Due to the existing conditions at the Highland Road/Euclid Avenue intersection, it was difficult to install an ADA curb ramp that exactly met the specifications.
