5. COMMUNITY ORGANIZATIONS ACTIVE IN DISASTER (COAD)

- Members are being encouraged to complete NIMS, ICS, and ESF training.
- Volunteer Management and Animal Management Committees will be formed.

*EXECUTIVE SESSION MAY BE HELD PURSUANT TO OHIO REVISED CODE (ORC) 121.22(G)

ORC 121.22(G)(5), a public body may hold an executive session to consider "[m]atters required to be kept confidential by federal law or regulations or state statutes."

ORC 121.22(G)(6) provides that consideration of "[d]etails relative to the security arrangements and emergency response protocols for a public body or a public office, if disclosure of the matters discussed could reasonably be expected to jeopardize the security of the public body or a public office." Under this exception, both conditions must be met:

⁽¹⁾ the subject of the meeting must relate to the security arrangements and emergency response protocols for a public body or a public office; and,

⁽²⁾ public disclosure of the matters discussed could reasonably be expected to jeopardize the security of that public body or public office.

- PBS station WVIZ hosts a series of panel discussion about career opportunities that is streamed to local high schools. Students have an opportunity to call in with questions. WVIZ is interested in doing one or two segments on emergency management.
- A follow-up program would engage youth in projects, field trips, and other activities to acquaint them with emergency management and public safety and hopefully motivate them to volunteer.
