- 7. THIRA DISCUSSION- CCOEM presented. Recap of 2014. Discussion of Core Capabilities for Health and Social Services and Public Health, Healthcare and EMS. Mass Fatality was deferred until CCMEO could be in attendance. Health and Social Services scenario was appropriate for Utilities Disruption with the addition of Cyber security. PH, HC and EMS scenario changed to Anthrax for immediate response planning with the understanding that infectious disease was for extended response planning. Both scenarios are significant for planning purposes. Impact, desired outcomes, target capabilities and resources were discussed and updated for each. Beth Gatlin to work with CCOEM for updated hospital resource requirements based on current capabilities. Survey tool may be used for compilation of data. Heidi Scaife to work with CCOEM for MCM numbers and resource issues identified during RNC planning. Goal to have all data to CCOEM by end of October.
