Currently, there are two companies that make GC/MS units for routine lab work. These companies are Agilent and Shimadzu. The drug chemistry section currently has three (3) Agilent units and one (1) Shimadzu unit. Both devices are capable of analyzing drugs satisfactorily with one critical exception. With the Agilent units it is possible to produce a report in about 20 seconds and reports are fully customizable. The ability to customize reports allows lab personal to present data clearly and in a concise format for presentation in court. Additionally, the ability to print custom single page reports quickly has allowed the drug chemistry department at the crime lab to go completely paperless in its data generation. This is a critical accomplishment since each year over 50,000 reports are generated. The Shimadzu lacks all of these features. Yes, it is possible to produce reports, however it is not possible to generate them in the format desired and they take considerably longer to produce. With the number of samples being analyzed increasing every year and with cases becoming more and more complex it is critical to be able to produce reports as quickly as possible so that analysis time can be focused on the actual processing of evidence (i.e. weighing, sampling, etc.)

The one Shimadzu instrument currently in operation in the Drug Chemistry Department was purchased eight years ago and is running on its original software package. As noted above, the software system has proven to be limited at meeting agency needs. Because of this, that instrument has been relegated to limited use for special testing for such things as anabolic steroids that tend to be very hard on instruments due to the nature of the samples. When initial discussions about new instrumentation began last year the Shimadzu Corporation was contacted to see if improvements had been made to their software to make it more user friendly. While the operating systems for their equipment are problematic the instrument itself is very robust, so drug chemistry personnel we curious to see whether improvements had been made that would make Shimadzu's instrumentation a viable alternative to Agilent. Drug chemistry personnel were informed that no improvements had been made to the reporting function of Shimadzu's operating system despite countless complaints from customers and even from their own employees. It is clear that this company is not listening to its customers to provide the type of services needed. It is because of this that a sole source request is being made.
