Our consultant Pandey Environmental consultant hired a subcontractor to take Asbestos Containing Material and Lead Paint samples of site for reuse of this vacant "vandalized building" for a potential community services social services applicant. Unbeknownst to the applicant the property had been damaged by vandals who destroyed walls and ceilings expanding the former retail buildings interior. The subcontractor took samples in all open and exposed areas in this "war-zone like interior", not knowing the square footage he sampled was larger than the square footage of the site given to us by applicant and quoted to the subcontractor/contractor. Therefore, the cost of the samples exceeded the originally budgeted amount.
- 2. What is Being done to prevent this from re-occuring? We as the county have no control over the change in the site parameters due to vandals prior to the environmental assessment being conducted. The subcontractor was unaware the price quoted was for a smaller square footage and acted on behalf of the health and welfare of the potential new occupants of the site. Who is our applicant: ICONS (Individuals Collectively Overcoming Negative Situations) is a non-profit organization currently leasing space at 2930 Prospect Avenue, Cleveland, Ohio, has an opportunity to purchase the former Faith Building located at 10640 St. Clair from the Glenville Development Corporation.
