#### 3. APPROVAL OF OCTOBER MINUTES

- Under Public comment, MARS should be MARCS.
- Kimbro motioned, Martin seconded. Passed with all AYES.

#### 4. RADIO TEMPLATE

- Brad passed out copies of the template.
- Health wanted to add other talk groups but emails informed them otherwise.
- DiCicco will provide updates for the CVD zones.
- A fire simplex zone will be added with a name to be created by Carroll.
- Metro parks has the capability to patch but search shows that this has not been used in a few years now. It is unknown when the last time the Metro parks has had their radios updated. Pete Greene will reach out to the Chief of the Metro Parks and see what they currently have and use. Greene will also see about updating their radios to include the Cleveland Regionals.
- The MOU signed by agencies that accepted radios gives the permission that their talk group be allowed in the interoperability template, however; just because one agency has another's template does not give it the ability to have those talk groups in the interops. Good example is the XPOST18 for OSP and their XPURSUIT talk group. Sharing the XMTAC's and XCUYCO's with agencies outside of the County is the goal, however; the concern is what billing will MARCS levy towards a user.
- Handke will reach out to USAR and verify the talk groups to be included in the interops template. USAR OPS will become M17 and zones after that will move up one. XWESTCOM will be M18. HTS/HLCRST will be M19. CVD will cover M20 thru M22.
- Removing the XWSTCMPD and LKWDPD cease those are day to day talk groups.
- Carroll wants the fire ground simplex to be called CUYFG.
- Zones 1 thru 9 can be programmed any way an agency would like with their day to day and their neighboring agencies for example.
- Will meet later this month on the final draft.
- Per Balasko, clone keys from Parma will be made available to programmers.

#### 5. RADIO ALLOCATIONS

• State has approved the boiled down version and the paperwork is with the County's procurement department. The hope is to have the RFP out in a few weeks so vendors can bid on the project.

### 6. COUNTYWIDE FIRE NOTIFICATION SYSTEM

- Antennas for the west side have been delivered and more testing will occur.
- The goal is to use the Highland Hills tower for testing.
- Equipment from Hillcrest will be moved to the Parma site so that coverage is better.

#### 7. EXERCISES/DRILLS FOR COM-L PARTICIPATION

- McCarthy says that the EOC will be open for the finals if the CAVS get to them so Palinkas should be contacted if a person is interested.
- North Olmsted is planning a drill with OEM.
