The vendor will be providing case management services for our Court Unruly Program (CUP) to assist in diverting youth away from official Court involvement. This will provide diversion services for those youth at an intake level versus coming to the Court's attention in an official capacity and be used in the Court's Intake Department.

BC2018-07

Juvenile Court

This vendor will provide the Court with a mental health clinician to be stationed at the Court's new Community Based Intervention Program. The clinician will assist Court staff with the running of groups and will provide short term solution focused interventions for youth involved in the program. This clinician will provide the clinical knowledge to assist Court staff in the running of this new program.

This clinician can assist Court staff, as well as, complete any assessments or provide short term solution focused interventions for youth involved in the program. It was determined that an individual with clinical expertise would be a great asset to this new program. The Court has received grant funds to provide this service. An RFP was released, and three vendors responded. This vendor was best qualified.

Public Safety and Justice Services requesting approval of an agreement amendment, with the City of Cleveland to extend the period of the agreement to end $\frac{1}{31/2018}$ **2/23/2018**.

Reason for late submittal: The City of Cleveland needed addition time to complete their bid process. The City of Cleveland will be purchasing early Identification technology equipment - tablets. The City of Cleveland will be able to report terrorist attacks and provide criminal activity from the field. which will change the workflow and processes. In-field reporting will allow for vital information to be uploaded in the system immediately and increase and enhance the capabilities of the Division of Police. There 7 were applications submitted in connection with the FY15 Law Enforcement- State Homeland Security Grant Program. The Law Enforcement Terrorist Prevention Program Advisory Board choses which applications are submitted to the awarding agency. Seven other applications were reviewed at the time. The tablets will be used throughout Cuyahoga County. The total cost is \$50,000.00. There will be a warranty purchased with the tablets, which will last up to five years. Leasing the tablets would be more expensive.

BC2018-15

County Law Library

Provision of an integrated library system, an online catalog, cataloging services, access to selected legal research databases, membership in the regional consortium called CLEVNET, Internet service, email service, and technical library support. The Law Library needs to maintain a current list of patrons, an online catalog of current materials, perform cost-effective and accurate cataloging of its materials, and receive technical library support for its operations. This will enable the Law Library to maintain a current list of patrons, an online catalog of current materials, receive cost-effective and accurate cataloging of its materials, and receive all of the benefits of membership in CLEVNET, especially technical library support.

CLEVNET provides: consistent, rapid access to an integrated library system and an online library catalog; accurate patron information, including patron circulation records; efficient circulation and discharge of

library materials; accurate cataloging and cataloged records; access to valuable databases provided; constant access to high-tech Internet and email; superior technical library support.

There are no other voluntary library consortia in Northeast Ohio that accept members of provide the same services. The Law Library has, through its predecessor, been a member of CLEVNET since 1985. The Law Library could not afford to separately purchase all of the products and services that the Agreement provides other than through consortial buying. These services will be used at the Cuyahoga County Law Library, Cuyahoga County Courthouse, 1 West Lakeside Ave., Floor 4., Cleveland, OH 44113

BC2018-16

FCFC contracts with the Educational Service Center of Cuyahoga County as the fiscal agent for the Families and Schools Together program, Parent Advocates and Parent Representatives for the FCFC office. As the fiscal agent, ESC is able to disperse and monitor funds for the FAST teams, trainers, and vendors. ESC is able to handle the high volume of checks which are processed and cut in a timely manner. An RFP was released in 2015 and ESC was the selected vendor.

BC2018-17

Family and Children First Council,

Evaluation of youth development program areas by conducting data analysis, evaluate, and/or report outcome measures for service coordination, out of school time, Families and Schools Together, youth advocacy, teen pregnancy prevention, and youth employment. Evaluation services allows monitoring of program areas to determine if services are meeting the needs of the youth and families involved in the services. The vendor will research and create benchmarks for each program area, develop and maintain a development management plan, and assist in strategic plan development. An RFP was released in 2016 with Case Western Reserve University being chose as the evaluation vendor.

BC2018-18

Division of Children and Family Services

The Cuyahoga County Court of Common Pleas, Juvenile Court Division, provides psychological evaluation services to caregivers to determine their ability to provide appropriate care to their children. The Juvenile Court Division also identifies linkages with appropriate intervention for community-based services as a Diagnostic Clinic. This service determines if caregivers have the ability to provide appropriate care to their children.

C – Exemptions

BC2018-19

Family and Children First Council,

FCSS is a funding stream approved through the Grant Application DOC# 1067159. The funding is used to administer a family-driven wraparound process that helps maintain young people in community based settings.

FCSS funds provides a flexible funding stream for families seeking services for community based wraparound assistance. Families can select local and accessible providers, which are often used one time. FCSS funds must be flexible for the following reason:

- -These state and federal dollars support non-Medicaid billable services.
- -FCSS focuses on maintaining children and youth in their own homes/communities by providing nonclinical family-centered services and supports. FCSS is built on the foundation that family involvement in service planning and implementation:
- a. is critical to successful treatment outcomes
- b. strengthens the existing capacity of families to improve family functioning
- c. ensures safety and well-being of each family member
- -The target population for FCSS is children birth to 21, with multi-systemic needs, who are receiving service coordination through the local FCFC partners.
- -Single agencies or programs providing service coordination (outside of the Service Coordination Mechanism) that may not be able to meet the needs or youth/families can make a referral to FCFC Service Coordination for cross-system team planning.
- -If these families meet the local criteria for FCFC service coordination and a FCFC Individual Family Service Coordination Plan(IFSCP) is developed, that family identifies as FCSS eligible and FCSS funds may be used for the purpose(s) identified in the IFCSP.
- -In order to prevent duplication of plans or conflicting expectations of the family, the agency/program plan should be integrated into or linked to the coordinated with the FCFC IFCSP.

Service Coordination is mandated in ORC 121.37. The Ohio Family and Children First developed this funding stream in conjunction with the Ohio Department of Mental Health & Addiction Services (OhioMHAS) to offer flexible wraparound services to families at the local level and reduce the number of children/youth in congregate care. The state guidance requires FCFC to maintain a copy of the Individual Service Plan with the application.

The total amount of the award is \$407,897.00 for the time period of 7/1/2017 to 6/30/2018. FCFC is requesting to maintain an amount not to exceed \$203,948.50 in order to pay for services for the families to various vendors from other agencies in which families are involved in such as Bright Beginnings, Children and Family Services, Juvenile Court, and Board of Developmental Disabilities who require community based services that are not covered by Medicaid. A separate transaction form is being simultaneously submitted for an exemption to seek an Inter-Agency Agreement with the ADAMHS Board of Cuyahoga County for the remaining half of the funds as so directed by the Ohio Family and Children First.

Family and Children First Council

Since 2005, Family and Children First Council were given funds named the Family Stability Incentive Program to help families who were in need of a one-time payment for services to help prevent further system involvement. Once the FSIP funds were no longer available, FCFC created a line item for Community Assistance. Community Assistance is a one-time funding opportunity available to all residents of Cuyahoga County as a last effort to help assist families with payments for rent, utility bills, and limited furniture items and appliances such as beds for children, stove, refrigerators, washers and dryers for larger families. Residents can apply through the Community Collaborative Resource Specialist. The maximum amount for the request per family is \$500.00. The families are required to pay half the amount of the request to FCFC. The family may not have involvement with Children and Family Services or Tapestry System of Care. The total amount allotted for the programing FCFC approved budget is a NTE \$50,000.00 from January 1, 2018 to December 31, 2018. An alternative procurement request is being made for this former Deputy Chief/Exemption approval item.

BC2018-21

Juvenile Court Division

This vendor provides outpatient trauma informed treatment services to youth involved in the Court's Safe Harbor docket. This provides specialized community based treatment services for a unique population of youth. This population requires services that can be provided by a specially trained vendor that has experience with this specific population. An RFP was issued for this service; however, this was the only vendor that responded. This will be used with youth that are involved in the Court's Safe harbor docket.

BC2018-22

Office of Procurement & Diversity,

This amendment request is to correct an error in the unit price reported in Eastbay's Reverse Auction Report. The unit price in the report was reflected as \$13.50/case instead of \$15.40 /case. This error was reported by the vendor and EasiBuy confirmed the error.

The original award was approved by BC2017-980 on 12/18/2017.

BC2018-23

Office of Early Childhood,

The purpose of this program is to reduce the incidences of infant mortality in Cuyahoga County but more specifically in the City of Cleveland.

Grant awards are to be made on December 31, 2017. The project is to run from January 1, 2018 through June 30, 2019. If and when we are awarded the contract, we will then accept and enter into a contract with the Provider (City of Cleveland/Department of Public Health) on behalf of the MomsFirst Program.

Item No. 1

Corrections Planning Board,

This grant award will provide funds to adopt policies and practices based on latest research as to how to reduce the number of offenders on probation supervision who violate their parole.

Item No. 2

Cuyahoga County Law Library

The purpose is to grant all Ohio County Law Libraries who apply a 25% credit or reduction in the 2% statutory dues Ohio County Law Libraries are required to pay to the Statewide Consortium of County Law Library Resources in February of 2018 pursuant to ORC 3375.481. The Cuyahoga County Law Library would like to obtain permission to apply for and receive a 25% credit off of its 2018 dues. The specific amount is undetermined at this point because the Law Library will have to wait until it receives all 2017 revenue to calculate its 2% dues and the corresponding 25% credit off of those dues.

The Statewide Consortium of County Law Library Resources Boards issued an RFP on October 18, 2017. Grant applications in response to this RFP are due by January 31, 2018.
