The meeting was called to order at 11:02 a.m. Attending: Armond Budish, Chairperson Councilman Dale Miller Councilwoman Nan Baker Trevor McAleer, County Council (Alternate for Dan Brady) Michael Dever, Director, Department of Public Works Angela Rich, Deputy Fiscal Officer, (Alternate for Dennis Kennedy) Lenora Lockett, Director, Office of Procurement & Diversity

II - REVIEW MINUTES - 2/20/2018

Armond Budish motioned to approve the minutes from the February 20, 2018 meeting, as written; Dale Miller seconded. The minutes were unanimously approved.

III – PUBLIC COMMENT

There was no public comment related to the agenda.

Anthony Stella and Greg Huth, Department of Development, presented. Armond Budish asked if the additional information previously discussed at the February 20, 2018 Board of Control meeting had been provided to the Cuyahoga County Community Improvement Corporation (CCCIC) Committee; and asked if the CCCIC is satisfied with proceeding with the Ioan. Trevor McAleer responded that the CCCIC received the information and is agreeable to proceed with this Ioan. Nan Baker requested confirmation that the CCCIC approved the Ioan. The County is managing a disparate catalog of siloed applications that have a low level of integration and are not assembled to support sharing of key data elements. To share information, many applications require re-keying of information and the applications exist in a loosely-coupled loosely integrated environment. The present environment requires manual processes for information sharing which waste time, is often inaccurate, untimely and doesn't effectively allow for cross-application queries and reporting. The County does not currently have either an operational or analytic Data Warehouse. Additionally, the County is presently implementing an Infor ERP application that will replace the existing IBM mainframe (financial and payroll), SAP (HR and Benefits) and Budgeting applications. Sun-setting those solutions will require an effective data archive solution.

The initial part of the solution (this project) is to develop an Enterprise Data Architecture Framework for the County, following the approach and methodology laid out by Navigator in their SOW. This project will also deliver Archiving and BI roadmaps and requirements, as well as recommended MDM tools. The projects that are offshoots of this project will implement approved recommendations to phase in the solution to the problem.

We do not have the capacity or expertise to do this within the County, so we went through the RFQ process, and based on the Vendor Evaluation of responses, we selected this solution. The Department of Public Works is requesting an RFP Exemption to complete various Department Orders wi9th the two primary suppliers of cement - Rockport Construction & Materials, Inc. and Carr Bros., Inc. for a period beginning March 1, 2018 through February 28, 2020 for Concrete Ready Mix in an amount not-to-exceed \$320,000.00.

Section 4.4(b) and 4.4(d) provides for the exemption from competitive bidding when approved by the Board. In order to maintain and repair the infrastructure needs of the County and the Communities that we serve, Public Works needs to respond timely when concrete areas of bridges, culverts, sidewalks, and streets are removed for repairs or replacements. Public Works crews are routinely removing concrete areas to solve infrastructure related problems. This action will allow the County to quickly restore the openings by using the above named registered concrete vendors and that can deliver concrete in a timely and competitive manner that meets the needs of the County. These are two vendors that do not mandate delivery restrictions when placing orders and have responded to previous bids.

In 2017, competitive Bids were solicited from the concrete suppliers in the County and pricing varied minimally, however, only the two selected suppliers were able to meet our criteria for delivery appointments and areas of service. The excluded vendors will only accept orders called in at the start of the work day and cannot predict when in the day the order would be delivered nor, will they accept advance preorders for the material. In January 2018, informal requests for quotes were sent out to 13 vendors on two separate attempts. Only the two selected vendors replied to each solicitation. No other quotes were received. This process will allow the County the greatest flexibility for delivery and most efficient usage of the crews by scheduling work assignments in advance. These specifications are communicated annually to ensure open competition.

To settle the matter, the Court intervened, and the County agreed to consider two estimates provided by the property owner for the installation. After much negotiation, the property owner agreed to accept the lower of the two estimates - \$6,780.

However, during construction, a mature maple tree was removed on the property and the property owner had not received compensation for its removal. The parties negotiated a cost of \$500.

The settlement totals \$7,280. The settlement amount represents an <u>increase of \$6,930.00</u> and is considered reasonable and far less costly than pursuing any further negotiations with this owner, or allowing this case to proceed to a jury trial.
