Armond Budish motioned to approve the minutes from the March 26, 2018 meeting, as written; Michael Dever seconded. The minutes were unanimously approved.

Michael Chambers, Department of Public Works, presented. Dale Miller asked if there was any information available detailing why there was only one responsive bidder for this purchase. Nan Baker asked for clarification on the difference between the Capital Equipment account Fund vs. Special Revenue Fund; asked if Road and Bridge (Special Revenue) Funds are utilized solely for vehicles and equipment; and asked how the funds are appropriated to the specific funding source to facilitate this purchase. Armond Budish motioned to approve the item; Dale Miller seconded. Item BC2018-195 was unanimously approved.

Nan Baker asked how payment for services are made to the vendor if the contract is expired. Armond Budish motioned to approve the item; Dale Miller seconded. David DeGrandis, Department of Information Technology, presented. Nan Baker asked for confirmation that this is a state contract purchase, which has been vetted by the State; asked for the Department to include relevant information in backup materials as it pertains to the procurement process for future purchases. Trevor McAleer asked if Integrated Precision Systems, Inc. is the only vendor that can provide this service; asked whether this item should be categorized as a sole source purchase instead of an RFP exemption; asked which component of this system can only be serviced by the vendor; and asked if this item could be presented as an alternate procurement and not an RFP exemption since this was bid out by the State. Dennis Kennedy, Fiscal Officer, commented that while this vendor is regional this is not a true sole source due to other service providers existing outside of Northeast Ohio. Mr. McAleer asked if current pricing comparisons were made to other areas including Columbus and Cincinnati. Mr. Kennedy inquired about the prior bidding history; stressed the need to explore alternatives; and confirmed that no formal bidding process was conducted, which makes the RFP exemption necessary. Richard Opre, Office of Procurement and Diversity, provided additional information on the RFP exemption process. Ms. Baker again stressed the need for detailed information to be included in the items detail section of the Agenda defining the procurement process utilized by Departments. Mr. McAleer suggested moving forward with this item but requested that further discussions be held with future potential bidders.

Development

Bristol Apartments, LLC - Forgivable loan not to exceed \$450,000 to assist in the development of 20 units of multifamily housing for the project known as Bristol Apartments located at 2928 South Moreland Road in the City of Cleveland.

The Cuyahoga HOME Consortium, at its regularly scheduled meeting on April 12, 2017 recommended a forgivable HOME funded loan in the amount not to exceed \$450,000 based upon the availability of federal funding. Department of Information Technology

Within the scope of the agreement, State of Ohio DAS/OIT will provide: IBM hosting for the IBM mainframe platform on a LPAR that includes but not limited to: mainframe OS and its associated software, network connectivity, virtual tape, data storage and backup, and offsite mirroring of virtual tape and data storage. Maintain business continuity for the County's IBM mainframe processing.

Provides an IBM mainframe platform for Cuyahoga County. The LPAR is used for the County's Financial and Accounting System (FAMIS) as well as other items on the Mainframe. It was part of the DAS hosting solution that allowed a County \$18 million-dollar data center build out to be avoided.

DAS hosting services provided a platform for the County server environment as well as utilizing the IBM LPAR for the mainframe applications. This is the most cost effective and logical solution since our data center is located at the State of Ohio Computer Center (SOCC).

All County departments that require access to Famis and other mainframe business applications

Using the State of Ohio government to government agreement. This is the required software for use at the SOCC. Last competitively bid in 2014

Department of Information Technology

This purchase will provide mobile access to applications and files for sheriff's office personnel.

This will be a desktop replacement, but will add the mobility feature, County standard equipment; Microsoft also offers included training that other vendors do not offer. Other solutions were not considered, but other vendors were looked at.

An RFP exemption is needed as a full competitive process was not used. Items are being purchased off of an Interlocal Cooperation agreement with the State of Texas Department of Information Resources.

BC2018-216

Juvenile Court Division

This vendor provides pharmaceutical products, as well as, medical supplies for youth residing in the Detention Center.

This contract will provide much needed medication for the youth residing in the Detention Center.

The youth residing in the Detention Center have various medical and/or psychological needs that need to be met. This will assist in providing that essential medical/psychiatric care.

This is the second RFP that was issued for this service and this was the only vendor that applied.

This will be utilized within the Detention Center.

BC2018-217

Juvenile Court Division

This vendor provides youth that are currently on community control with evidenced based anger management group therapy services.

This service provides yet another option for community-based services for those youth involved with the Court system.

This service will provide access for youth to an anger management group therapy program to assist these youth in managing their anger impulses within the community.

This is a much desired and needed program within the Court.

An RFP was completed back in late 2016 for this program, and this vendor submitted the best quality proposal. The program is scheduled to be re-RFP'd at the end of 2018.

The Court is amending this contract to add in the second year of funding.

BC2018-218

Juvenile Court Division

The vendor will be providing on-site technical assistance and video conferencing services to those Court staff who have been trained in Cognitive Behavioral Interventions - A Comprehensive Curriculum (CBI-CC). This will assist staff in adhering to the fidelity of this model of treatment. Staff will be able to continue this treatment with youth involved in the Community Based Intervention Center.

BC2018-220

Public Safety and Justice Services, 2018 submitting a contract for the FY17 Title II Formula Grant (CY18), in the amount of \$29,444.55.

Cuyahoga County Juvenile Court's project C.A.L.M. (coordinated approach to low-risk misdemeanors) will provide services aimed at providing minority youth an alternative to detention in the juvenile justice system.

The project dates for the FY17 Title II Formula JJDP Block grant are January 1, 2018 through December 31, 2018.

There is no match associated with this grant.

The primary goal of the funding for this this project is to decrease the contact that minority youth in Cuyahoga County have with the law enforcement and the juvenile justice system.
