The County competitive process was not used as Integrated Precision Systems, Inc. (IPS) is able to provide the needed Security Camera and Storage solutions on Ohio STS #800545 which expires on January 31, 2021. In order to provide consistency in the management of the large enterprise networked security system, it is essential that a single vendor provide and maintain any equipment that is being added to this system. Had another vendor been selected, the County would be running multiple independent security camera systems. Such a decision would have returned the County to the Balkanized nature of the security systems that are being upgraded and replaced.

The cost, customer service level, systems knowledge, among other characteristics were considered in evaluating the services and equipment provided by IPS. The equipment and services provided meet the County standards for such equipment as defined by DoIT. The quoted price from Integrated Precision Systems, Inc. (IPS) is \$91.00 below State Contract Pricing.

While cameras themselves have not been competitively bid, storage servers and licensing were bid in 2012. Based upon that process, IPS has provided reduced pricing for certain licensing and server equipment.

Reason for Termination: the contract with Olmsted Falls was terminated after a new mayor, James Graven, was elected, and he indicated his desire to cease the pilot project.

As nearly \$35,000 in costs had been accrued since the inception of the pilot project, that left DSAS with only \$15,000.00 of the initial \$50,000.00 to spend on this project. As that was not enough to sustain another pilot in a different municipality, DSAS opted to terminate the contract and decertify the funds.

Olmsted Falls does not have issues with overuse of the 911 system, repeat emergency room visits or primary care shortages. The County and City are in agreement that a community with a large senior population and high hospital readmission rates will benefit from community paramedicine services. Olmsted Falls will not benefit from such services, per the city.
