Office of Re-entry

This program will offer intense intervention treatment and support to individuals who are identified as medium to high-risk who will return to Cuyahoga County communities within a six-month time period. A full continuum of screening, assessment, treatment and supportive services is intended to help clients and achieve goals for successful reentry and develop a plan that will prevent them from reoffending. R.R. is designed to meet identified behavioral health and recovery support needs for participants, measure the short and long-term impact on inmate behaviors, and provide continuity of care to support successful reentry. Office of Homeless Services

The Salvation Army provides temporary housing with supportive services for 75 homeless men at a point in time, and over 200 men annually.

Homeless men are referred to the PASS Program from 2100 Lakeside, the emergency shelter for single adult men. At the PASS program, the case manager to client ratio enables clients to have a higher level of services for job training and placement and for locating permanent housing.

The PASS program is a low barrier facility that works with clients to exit homelessness as quickly as possible. recovery supports are available on site as well as links to mental and physical health resources. The Salvation Army was awarded an Innovative Grant in 1994 by the U.S. Department of Housing and Urban Development (HUD) to implement the PASS program. At this time, the PASS program continues to receive "Operating" funding from HUD. This project is a critical component in the Continuum of Care capacity to meet the needs of homeless, single men.

A competitive process was not used as The Salvation Army created and implemented the program. The Salvation Army has dedicated space within Harbor Light to accommodate 75 homeless men in private and semi-private rooms. Meals and laundry access are provided. No other provider has this type of resource to commit to the project. PASS is located at Harbor Light, 1710 Prospect Avenue, Cleveland, OH, 44115.

Office of Early Childhood

The hiring of a central coordinator for the ECMH program is essential to better coordinate referrals from the community, parents, service providers and others. Early childhood mental health services encompass a continuum of approaches in working with young children and their families that include the promotion of healthy social and emotional development, the prevention and early intervention of mental health difficulties and the treatment of mental health conditions among very young children in the context of their families.

The ECMH Coordinator will have the ability to triage cases and send them to the appropriate ECMH program provider in the system. This will allow us to better manage the waiting list for ECMH services.

The goals of the Early Childhood Mental Health (ECMH) program are to identify children, ages 0 to 6, in need of ECMH services, ensure timely access to ECMH services, engage the family in a treatment plan, and assure that necessary follow-up and transition services occur. The hiring of a central coordinator for the ECMH program is essential to better coordinate referrals from the community, parents, service providers and others. The ECMH Coordinator will have the ability to triage cases and send them to the appropriate ECMH program provider in the system. The ECMH Coordinator position is being funded in collaboration with the Alcohol, Drug Addiction and Mental Health Services Board, Cuyahoga County Board of Developmental Disabilities, Division of Children and Family Services, Office of Early Childhood, Help Me Grow and the ESC. Because of this unique funding structure and the ESC's role as a fiscal agent we felt this was a good fit for this position. The other possible solution would be that the County directly hires the ECMH Coordinator since a majority of the cases the Coordinator receives has traditionally come from the Division of Children and Families Services. We will explore this possibility over the next six months or so to determine if this is a possibility.

The Coordinator position that is a vital piece to our ECMH system and we will work on different ways to keep it moving forward with either stable county/community funding or grant funding

Office of Early Childhood

Ready Rosie provides short videos (less than 3 minutes), Teachers will select videos to push out to parents via e-mail which correspond to the weekly lessons plans. The videos outline and demonstrate age-appropriate cognitive and social developmental activities that parents can do with their children right in their own home, and typically with no expense by using common household items.

Also, Ready Rosie will provide a one-day training and professional development for parents, teachers and administrators.

Pascal Learning produces and distributes (via web streaming) a set of unique child development videos under the brand name "Ready Rosie." School districts and other programs that serve young children and prepare them for successful entry into Kindergarten, subscribe to the Ready Rosie series so that it can be provided to their client parents.

To help UPK programs better prepare their children for entry into kindergarten the Ready Rosie videos can be customized around lesson plans for the week. These videos will be provided by Pascal Learning to the teachers who can then target them to their families from their classrooms. Pascal will provide training on how to do this to the teachers.

We learned of Ready Rosie when it was featured as a best practice at a national early childhood development conference attended by Invest in Children Director, Rebekah Dorman, PhD. We have had numerous conversations with Pascal Learning and have found them to be exemplary in their willingness to customize their product to Cuyahoga County's needs.

Other options were not investigated as we are currently working with Pascal and have found them to be a good partner. They are the only entity currently producing Ready Rosie videos and the service that distributes them to parents.

Cuyahoga Job and Family Services

This is a unique and innovative approach to redesigning the role and responsibilities of foster parents. It improves care for children by enhancing recruitment and retention of foster parents.

This service is needed to enhance the agency's foster care programming to build and increase capacity within Cuyahoga County for the placement of Level 1 & Level 2 children in the agency's own network of licensed family foster homes. Currently, over twenty-five percent of the children in custody are placed outside of the county.

The Youth Law Center developed QPI in 2008 and is the only organization that has experience in implementation. Participation in QPI involves participation in a network of QPI sites across the United States and this network is coordinated by the Youth Law Center. DCFS will benefit from the peer-to-peer learning and support provided by other child welfare sites within the QPI network.

Late submission is due to lengthy contract negotiations. The vendor has not provided services under this contract.
