Purchase of two thousand (2000) Microsoft core access licenses (CALs) to use for authentication to move toward single-sign on for multiple county applications (AD, email, sharepoint...). Currently, users use multiple accounts/passwords to access various County applications. Employees often confuse or forget which account/password applies to the correct application. Each AD account requires a Microsoft CAL. The county must purchase a CAL for each employee required to authenticate to County applications. A Microsoft license for authentication is already in use by the County and is the preferred method of single sign-on authentication. These licenses are a Microsoft product in which the county has an MSA with Dell Marketing LP as the required vendor to provide all Microsoft licensing. Software not purchased through this vendor via the agreement will not have free software assurance/upgrades.

The county is contractually obligated to purchase its Microsoft licensing from Dell Marketing LP via the Microsoft Enterprise Agreement. This was competitively bid 12 months when the MSA contract was bid and negotiated.

Department of Information Technology

This procurement is for seven (7) video surveillance cameras, a video management server, and seven (7) XProtect Corporate Device Channel Licenses for the exterior of the Virgil E. Brown Building. Existing exterior cameras at this facility are no longer functioning. This procurement will enhance the existing security measures for this facility. Currently, the roof (at two different levels) is being replaced. This is the opportune time to install the new cameras. These additional security cameras will enhance the perimeter security of the facility. These cameras will cover entrances to the facility, including the delivery dock and underground parking area. These recommendations are based upon reviewing existing security architecture throughout the County. Having conducted interviews with departmental stakeholders, drawings and schedules have been created, reviewed, and revised, resulting in the existing proposal. Other solutions may be to increase the number of security personnel and provide additional shifts of security personnel. However, this may be considered cost prohibitive. This equipment will be used at the Virgil E. Brown Building, but video may be viewed from any computer accessing the County network with authorized credentials. One year of maintenance is included with this procurement. Upon the end of the first year after installation, this equipment will be added to the master maintenance agreement through the true up process. This will add approximately \$3,000 per year to the master maintenance contract.

This RFP exemption is needed to make a purchase off a State Contract.

Integrated Precision Systems, Inc. (IPS) is able to provide the needed Security Camera and Storage solutions on Ohio STS #800545 which expires on January 31, 2021. In order to provide consistency in the management of the large enterprise networked security system, it is essential that a single vendor provide and maintain any equipment that is being added to this system. Had another vendor been

selected, the County would be running multiple independent security camera systems. Such a decision would have returned the County to the Balkanized nature of the security systems that are being upgraded and replaced.

The cost, customer service level, systems knowledge, among other characteristics were considered in evaluating the services and equipment provided by IPS. The equipment and services provided meet the County standards for such equipment as defined by DoIT. This was last bid Probably 2001.

Department of Information Technology

The Solid Waste District is having issues with Power Point and opening documents that is being caused by using an outdated version of Microsoft Windows. The lack of the updated software is preventing the completion of our daily work.

Moving from the current outdated version of Microsoft Windows to the county's new Windows Office 365 Subscription version will resolve this issue.

Discussions with the IT Department determined that converting to the county standard Windows would be the best option for the Solid Waste District.

This is the county standard and the county is contractually obligated to purchase its Microsoft licensing from Dell Marketing LP via the Microsoft Enterprise Agreement.

An RFP exemption is needed as Microsoft Office 365 Subscription Licenses are already in use by the County as its standard. We are asking that these licenses be purchased as an RFP Exemption because the county is contractually obligated to purchase its Microsoft licensing from Dell Marketing LP via the Microsoft Enterprise Agreement. No other solutions were considered, as this is an amendment to another agreement between government agencies. The audit covers County wide financial statements and disclosures.
