Data Warehouse: MOU’s sent to all chiefs and RMS vendors. Processing times will vary. Completing contracts with Sundance, Securus, and testing with LInX. Contract for Protection Order with CVD in approval process.

Handout with locations of fixed LPR location, 20 fixed sites, total of 80 cameras (attached). Noted additional sites to be funded through grants. Discussion regarding successes, federal partners with the LPR cameras, issues and downtime.

Prosecutor O'Malley asked for a list of applicants for cameras and noted utilization of the information provided as part of the application criteria.

Discussion regarding active protection orders. Joe Greiner asked about data entry process. Brandy Carney suggested a Law Enforcement subcommittee to support the build-out efforts so that all data components are interfaced correctly with respect to the courts and law enforcement.

Timeline for City of Cleveland's integration into data warehouse system was asked by Chief Malley. Mike Herb stated nothing definite. Prosecutor O'Malley noted Cleveland's new RMS and electronic integration into the court system as progressing.
