The grant funding will enable the Cuyahoga County Law Library to purchase: a standing touch kiosk to provide patrons with a self-service touch screen for accessing information about the library and its programs and services; a 2-way foreign translation device that will enable patrons and staff to easily communicate back and forth and overcome otherwise difficult language barriers; a closed-back table throw and retractable banner for use during on-site library programming and at outside events which the Librarian attends to promote the library; an Oculus Go headset and carrying case to allow patrons to experiment with educational, law-related virtual reality content; and an HP printer for use at a dedicated County workstation for accessing the County's mainframe, Intranet, and HR portal.

Procurement

The Consortium issued an RFP for optional grants in November 2018. In response, the Cuyahoga County Law Library obtained County approval through BC 2019-102 to submit a grant proposal to the Consortium.

Project Status and Planning

With prior approval (BC2019-102), the Cuyahoga County Law Library submitted a grant proposal to the Consortium on February 12, 2019. On April 5, 2019, the Consortium awarded the Cuyahoga County Law Library \$3,395.95 for technology and programming for patrons.
