I. Call to Order / Roll Call

Chairman O’Malley called the meeting of Sept. 6, 2019 to order. Roll called, quorum in attendance.

II. Approval of Minutes

Motion to approve the meeting minutes of April 5, 2019; Chief Bobak moved; seconded by Prosecutor O’Malley; all in favor, minutes approved.

III. Public Comment None.

IV. Old Business - *LPR Vendor Update*

Mike Herb and Dan Grein discussed LPR camera operations. Request for Board approval to extend the current contract for an additional 6 months for maintenance at no costs. Chairman O'Malley moved; Brandy Carney 2nd the motion; all in favor; none opposed. Mike Herb noted additional grant funding available for the fixed cameras. Ohio EMA requesting sealed bids. Awaiting approval from FEMA.

V. New Business – *Data Warehouse Training Demo*

Mike Herb presented a live demonstration of the training being provided for use of the data warehouse. The training lasts about an hour. System is web based and requires two-factor authentication to login. The warehouse was primarily built as an officer safety tool, but there are obvious benefits to detectives and analysts. Positive feedback received from those who have participated. Training has been completed individually with numerous police agencies at roll calls and Detective meetings. There were also two general trainings conducted at the Sewer District which had many attendees. The training has been “train-the-trainer” style.

Board discussion regarding TAC, additional agencies interested in access and sharing information, Adult Probation, Ohio State Highway Patrol. Would like to include the Bureau of Motor Vehicles. Chairman O'Malley complimented the system, noting importance of Cleveland being on board. He asked about RTA, CMHA and MetroParks, to which Mike responded interfacing costs preclude their ability to connect. Questions as to who would have the most valuable information. CMHA will likely be the next partner as they utilize the same RMS vendor as the Cleveland Division of Police.
