Procuring the services of this sole source provider will allow for the uninterrupted administration of the County's Class Plan.

While other job evaluation systems are available on the open market, the Archer System is a unique pointfactor system developed by the company which utilizes a weighted system of compensable factors which has been used for over 25 years to evaluate the County's non-bargaining unit classifications for purposes of determining their appropriate placement in the County's compensation system. It is imperative to continue to utilize this same system for revised or new classifications to ensure equity in the process of determining pay grades. Switching to another system for new or revised classifications would slowly degrade the integrity of the system that is in place for all the other classifications and is likely to lead to important inequities over time.

Alternatives were not evaluated, for the purposes stated above.

PERSONNEL REVIEW COMMISSION REVENUE GENERATING AGREEMENT WITH THE CITY OF SEVEN HILLS Scope of Work Summary

Personnel Review Commission submitting a revenue generating agreement with the City of Seven Hills for the anticipated receivables in the amount not to exceed One Thousand Nine Hundred and twenty-Seven Dollars (\$1,927.00). The anticipated start-completion dates are December 16, 2019 to January 30, 2020. The PRC anticipates the project will require no more than 45 days to complete. The work may be completed in less than 45 days or could potentially take longer than 45 days due to delays in receiving content and confirmations from persons involved in the development of each specific classification specification.

This project will require two distinct components: 1) work necessary to complete classification specifications for five (5) positions with the CITY and 2) work necessary to collect and collate salary data from relevant labor markets. The PRC estimates that each of the five (5) classification specifications will require approximately six (6) hours to complete, an additional sixteen (16) hours for collecting and collating salary data, and project management of approximately three (3) hours for a total estimate of forty-nine (49) hours.

Scope of Work Summary

Division of Senior and Adult Services requesting approval of an alternative procurement process to add vendors to the Options for Independent Living Master Agreement via amendment. This amendment is to add vendors of Homemaking and Personal Care services to the Master Agreement. The scope of services, term, and value of the Master Agreement will not change.

R2017-0235 R2018-0221 R2019-0176

The Options program has experienced a 37% increase in demand for Homemaking and Personal Care services since 2017, and additional vendors are required to serve the higher number of clients seeking these services. Funding is available within the Master Agreement to provide these services, but the current providers lack the capacity to serve the current caseload, particularly in difficult-to-staff geographic areas.

Using the alternative procurement method, DSAS will assess the demand in specific geographic areas and select vendors from the original 2017 procurement that serve those high need areas. This alternative procurement is critical to meet the immediate needs of seniors so they may remain in their homes.

An amendment will be drafted upon approval of the Alternative Procurement process.

Selected vendors will be added to the Options Master Agreement via amendment. This amendment will not occur until after the current pending amendment to add funds and extend the term of the master agreement to 12/31/2020 has been approved. No additional dollars will be added to the master agreement when the vendors are added, as the pending level of funding for 2020 will accommodate the services rendered by both the existing vendors and new vendors.

The primary goals of the Options program are:

- To promote self-determination by providing subsidized services to clients so they can remain safe and comfortable in the community.
- Direct services are delivered to clients age 60 and older who met a Protective Level of Care and have incomes up to 300% of the federal poverty level while also not qualifying for a funding source like Passport.
- To extend the amount of time a client is able to reside at home before requiring more intensive services.

Procurement

The original contract was the result of an RFP for these services in 2017, and DSAS is seeking to add vendors who responded to the RFP in order to meet the current demand for Homemaking and Personal Care services.

DSAS is seeks to amend the master agreement to add vendors. There will be no change to the scope of services, term, or value of the master agreement.

The MOU is used to set expectations and ensure communication and coordination between the County and the public sector partners for The Lab. It outlines the responsibilities of each party, the term of the agreement, how to terminate the MOU, and what partner organizations need to know regarding use of products or services as part of The Lab. MOUs were developed in partnership with the Law Department to allow for other public sector agencies to join Cuyahoga County in participating in The Lab. Through these MOUs additional test environments and subject matter expertise will be made available to local entrepreneurs and business, expanding the reach and impact of The Lab and allowing the program to support a diverse cohort.

The success of an entrepreneur or business isn't based on an idea alone. Access to mentoring, capital, and customers is essential for entrepreneurs and businesses to overcome the barriers to entry that exist in any market. The Lab will support the growth of the local economy by creating a test-bed environment for local entrepreneurs and businesses to gain real-world feedback on their idea, product or service before launch.
