3. APPROVAL November 13 MINUTES

4. ELECTIONS

Chair Nominations/Election - Call for nominations for Committee Chair; on separate two motions to nominate Steve Greene and close nominations so moved by TJ Martin, seconded by John O'Flaherty. Motion passed by unanimous vote.

5. BYLAWS

- S. Greene briefly discussed the changes made. CCESAB requires the bylaws be reviewed every three years. The changes proposed are as follows:
 - CCESAB allows alternates for the Chair and Vice-Chair for voting purposes only.
 - The Center for Health Affairs and Public works were removed.
 - OEM membership was reduced to one.
 - Public Safety and Justice Services was added.
 - Regional Dispatch membership was increased by one and East/West was removed.
 - Law Enforcement membership was increased by one; Members now include Municipal, Non-Municipal and Sheriff/Sheriff's Deputy. Chief Elliot said fire and police should have equal representation at meetings.
 - Section 2.09 Vacancies was added to address how a vacancy shall be filled.

Motion of the First Reading of the bylaws by TJ Martin, seconded by Randy Kimbro. Motion carried.

Updates were provided by several members and sent to Adam Griffith. Adam is in the process of making the updates and changing some of the formatting. Plan should be complete by the March 11th meeting.
