Nan Baker asked is there is a considerable cost savings to holding a virtual job fair rather than an in-person event; asked how many of the 2,700 participants were hired; and asked for clarification of the funding sources.

Mr. Chambers said that this service was already approved and that this item is to amend a contract with the same money; stated that this request will not change the commitment but is to only amend an already agreed-upon communications plan contract and the funding was already determined.

Mr. McAleer asked Mr. Chambers if he is comfortable that this request is not for additional funding.

Offenders are mandated by the Cleveland Municipal Court, suburban courts and Cuyahoga County Common Pleas Court to receive domestic violence education.

DIET offenders must attend one, two-hour session per week for 16 weeks. Each session, which averages 15 participants, is led by two qualified staff facilitators who stress one of the eight themes: non-violence, non-threatening behavior, respect, support and trust, accountability and honesty, sexual respect, partnership and negotiation, and fairness.

The anticipated start-completion dates for the program are from July 1, 2019 to June 30, 2021.

The primary goals of the project is to provide manualized services utilizing the evidence-based Duluth Model to offenders convicted of Domestic Violence by the Cleveland Municipal Court or the Cuyahoga County Common Pleas Court.

This item is late due to the State of Ohio - Bureau of Community Sanctions (BCS) program review of the DIET program in the spring of 2019. The outcome of the BCS review resulted in recommendations to the Corrections Planning Board and Cleveland Municipal Court as related to potential programmatic changes required to bring the DIET program into compliance with BCS standards. Based on this feedback from BCS, the Corrections Planning Board and the Court of Common Pleas requested that the Cleveland Municipal Court make changes in the delivery of DIET services.

The Cleveland Municipal Court conducted a review of potential promising and/or Evidence-Based service delivery options available for Domestic Violence offenders. The outcomes of this search resulted in a protracted negotiation with the University of Cincinnati to be included in the evaluation study on a promising practice (Cognitive-Behavioral Interventions for Domestic Violence: CBI-DV). This was one of the programs recommended to Cleveland and the Corrections Planning Board to bring Domestic Violence services into compliance with grant standards.

In November 2019, Cleveland Municipal Court and the Corrections Planning Board learned the Cleveland DIET program would not be able to receive the requisite training for CBI - DV until minimally late summer 2020. At this time discussions were held between the Cleveland Municipal Court, Corrections Planning Board, Common Pleas Court and the State Bureau of Community Sanctions to determine alternative options to move forward, while at the same time bringing the DIET program into compliance. The outcome was to implement a temporary solution for programming until such time as training by the University of Cincinnati.

The recommended temporary programmatic changes were incorporated in the Correction Planning Board's contract with Cleveland Municipal Court. The proposed contract was sent to Cleveland Municipal Court on 12/02/19. There, the Cleveland Chief of Probation, Director of Fiscal, Legal, Deputy Court Administrator, Court Administrator and the Presiding and Administrative Judge of Cleveland Municipal Court completed reviews of the contract.
