II – REVIEW MINUTES – 7/20/2020

Michael Chambers motioned to approve the minutes from the July 20, 2020 meeting; Trevor McAleer seconded. The minutes were approved by unanimous vote, as written.

Thomas Pavich, Department of Public Works, presented. Dale Miller asked what the contract status will be after 7/31/2020. Nan Baker asked why it took so long for the vendor to produce the final invoice and commented that the department needs to be proactive and stay ahead of contracting issues so that the Board is not asked to approve contracts just before they are ready to expire. Michael Chambers motioned to approve the item; Trevor McAleer seconded. Item BC2020-420 was approved by unanimous vote.

Paul Herdeg, Department of Development, presented. Dale Miller asked if the presentation to the senior leadership team will be in person or virtual; and requested that County Council members be invited to the virtual meeting. Nan Baker asked if there are cost savings by conducting the presentation virtually rather than in person; asked if these costs may be eligible for CARES Act reimbursement due to the need to conduct presentation virtually because of COVID-19 concerns; and indicated she would also like to also attend the presentation. Michael Chambers motioned to approve the item; Dale Miller seconded. Item BC2020-421 was approved by unanimous vote.

#### BC2020-422

Department of Information Technology, submitting an amendment to Contract No. CE1600274 with Infor Public Sector, Inc. for information technology services and solutions for the Enterprise Resource Planning System for the period 10/27/2016 - 10/26/2021 to modify the scope of services, by providing support to the Department of Human Resources for the preparation and deployment of Open Enrollment, effective 8/7/2020 and for additional funds in the amount not-to-exceed \$108,00.00.

Jeanelle Greene, Department of Information Technology and Jack Rhyne, Project Manager, Infor, presented. Ms. Greene indicated that the funding source should be changed to Self-Insurance Fund. Nan Baker stated that this is the third year of this contract and asked if the requirements have changed this year that would necessitate the continuation of these services and what will be different next year so that the County will not require services; asked if the cost decreases each year the contract is extended; and asked if the purchase is considered to be operating funds. Trevor McAleer concurred with Ms. Baker's comments and stated that the department indicated last year that the prior amendment would be the final for these services and hopes that this is the last year for this contract. Michael Chambers motioned to approve the item; Trevor McAleer seconded. Item BC2020-422 was approved by unanimous vote, as amended.

Department of Information Technology, submitting an amendment to Contract No. CE1700329 with Hawk Search, Inc. for Web Search Tool services for the period 11/27/2017 – 12/4/2021 to extend the time period to 3/4/2022 to modify the scope of services, to integrate software as a service (SAAS) with SiteFinity CMS to allow for user-friendly searches on County websites, effective 3/5/2020 and for additional funds in the amount not-to-exceed \$59,850.00.

Jeanelle Greene, Department of Information Technology, presented. Nan Baker asked what factors led to the 5-month delay in submitting this amendment for approval. Trevor McAleer asked if the Board of Elections and Department of Health and Human Services were added site users after the fact or were they intending to participate from the beginning; asked if there will be other agencies added as site users in future contract amendments; and asked for follow up on who those agencies will be. Michael Chambers motioned to approve the item; Trevor McAleer seconded. Item BC2020-423 was approved by unanimous vote.

#### BC2020-424

Department of Information Technology, submitting an amendment to Contract No. CE2000485 with Carahsoft Technology Corporation for Enterprise Select Chat Operation software subscriptions and support services for the period 2/18/2020 - 2/17/2021 to extend the time period to 7/12/2021, to modify the scope of services, to purchase (160) Enterprise Grid software subscription upgrades, effective 7/27/2020 and for additional funds in the amount not-to-exceed \$36,934.92.

Jeanelle Greene and Jeremy Mio, Department of Information Technology, presented. Nan Baker asked why the services are only being extended for 5 months; asked if the rate has remained the same during the extension period and if any State funds are available to pay for services or if we are paying more because the extension is only 5 months; and asked if it is more labor intensive or requires additional staffing to manage this solution. Trevor McAleer asked for clarification on the department's responses to the advance questions and asked how the department will analyze the return on investment when the contract ends; and asked if the department is satisfied with the system so far. Michael Chambers motioned to approve the item; David Marquard seconded. Item BC2020-424 was approved by unanimous vote.

Mike Foley, Department of Sustainability, presented. Trevor McAleer asked for clarification on the use of grant funds and how will they be applied to the project; asked for clarification on how the grant was written and the approved grant conditions; asked what metrics will be used to track success of the project; asked if this contract is for marketing services only; asked why the contract is for a 2 year period when it is anticipated that the marketing plan will be complete during the first quarter of 2021, as stated in Mr. Foley's presentation; and asked for clarification if 300 new jobs is the baseline, but expects the number of new jobs to be much higher upon project completion.

Nan Baker asked for clarification on the funding breakdown and total project cost; asked what the \$20,000.00 from the Sustainability Fund will cover and is it needed to get the project off the ground; asked if there is any collaboration with the Development of Development or local farmers on this project; asked what will be additional criteria to gauge the return on investment, aside from the creation of approximately 300 jobs; and asked if 1,000 new jobs would be possible. Michael Chambers motioned to approve the item; Dale Miller seconded. Item BC2020-425 was approved by unanimous vote.
