This is a RFP Exemption request with award to FDL Marines db Edgewater Marina in the amount not-to-exceed \$13,232.41.

A competitive process for this purchase order is not practical due to the volatility of fuel prices. As we have done in the past, we have contacted local marinas in search of firm pricing, with the only responses that we will be sold fuel at the market rate. Since fuel fluctuates frequently, vendors are not willing to lock in prices or blanket discounts. Due to this situation, we have elected to award to FDL Marine, which runs Edgewater Marina. The reason for this choice is this is the marina where the patrol boat is currently docked and operates from. This allows fueling without the need for travel, which saves funds in the form of fuel expended and payroll for officers on the marine patrol.

In the past, the Sheriff's Department worked with Public Works to determine if the marine fuel could be purchased under or added the Public Works' contract for fuel. This was not pursued further as marine fuel is a different grade and there is no feasible way to fuel the boat from a Public Works location as the boat needs to be fueled in the water.

The quotation total includes Shipping, Installation, Training. the critical instrumentation necessary to perform high level, scientifically defensible forensic examination of evidence.

- c) the foremost instrumentation for clandestine drug testing needed to address the increased complexity of multiple adulterants and components due to the opioid crisis.
- d) the fastest, user-friendly profiling device(s) with laboratory grade accuracy to reduce time while increasing productivity and quality control.

The foremost instrumentation of the proposed project aligns with the accreditation requirements of the Cuyahoga County Medical Examiner's Office Regional Forensic Science Laboratory by the ANSI National Accreditation Board (ANAB) whereby the laboratory is responsible for analyzing evidentiary material associated with criminal investigations within the County. The proposed project will provide scientific equipment with laboratory grade accuracy to reduce time while increasing productivity and quality control.
