I – CALL TO ORDER

The meeting was called to order at 11:01 a.m.

II – REVIEW MINUTES – 9/21/2020

Michael Chambers motioned to approve the minutes from the September 21, 2020 meeting; Leigh Tucker seconded. The minutes were approved by unanimous vote, as written.

There was no public comment.

B. - New Items for Review

BC2020-542

Department of Public Works, recommending an award on various Purchase Orders and enter into a master contract with various providers in the total amount not-to-exceed \$450,000.00 for temporary staff for COVID-19 screening services for various County buildings for the period 9/28/2020 - 6/30/2021 12/31/2020:

- a) Purchase Order No. 20003180 with Alliance Solutions Group in the amount not-to-exceed \$150,000.00.
- b) Purchase Order No. 20003179 with GPI Enterprises, Inc. in the amount not-to-exceed \$300,000.00.

Funding Source: CARES Act Funds

Thomas Pavich and Nichole English, Department of Public Works, presented. Lenora Lockett asked if Alliance Solutions Group was registered with the Office of the Inspector General. Mr. Pavich stated that Alliance Solutions Group was registered under the name of their parent company.

Trevor McAleer asked how much money is projected to be spent for screening services before 1/1/2021 and also the costs in 2021 through 6/30/2021 and asked how the amount of \$450,000.00 was determined; asked if the two recommended vendors' bids had the lowest hourly rates; asked what funding source will be used if services are still required after 12/31/2020; requested that the department provide regular updates to the Board members to track expenses incurred.

Mr. Chambers stated that if services continue into 2021 that chargebacks to the buildings may be necessary and asked the department to work the Matt Hruby, Fiscal Office to ensure proper funding allocations are being used.

Nan Baker expressed concern that a second funding source is not identified with this request to accurately reflect where the expenses will be paid from if services are to continue in 2021 since CARES Act funds must be used in 2020; and asked if this contract should end 12/31/2020 and be amended at the end of the year if services will continue, where the proper funding source can be identified.

Mr. McAleer acknowledged the importance of these services that were secured with a proper bidding process but concurred with Ms. Baker's recommendation to end this contract on 12/31/2020 and amend in the future when there is a clearer picture on the state of the pandemic.

Ms. Baker asked Mr. Chambers if he is comfortable with the request, as written.

Michael Chambers expressed his support to allow the contract to continue through 6/30/2021 due to the challenges of the new system, deadline dates for end of the year activities, locking down funds now that could be used elsewhere and stated that he does not want to penalize the vendor with delayed payments or go without services, due to these challenges.

Ms. Baker expressed concern that the General Fund will most likely be tapped into next year while this request still identifies CARES Act as a sole funding source, which will no longer be available in 2021.

Mr. Chambers stated that the Fiscal Office is getting ready for next years' budget updates and that this would be a significant impact while there is still uncertainty about next years' revenues and getting through the flu season; and indicated that the funding will most likely be General Fund and Health and Human Services Levy Fund if screeners are in Health and Human Service buildings.

Mr. McAleer recommended changing the end date of this contract to 12/31/2020 and keep the amount the same and the department could process an emergency purchase at the end of the year, if required; expressed reservations about committing non-existent General Fund or Health and Human Services Levy dollars for 2021 with no discussion; said that an emergency purchase does not necessarily need to be funded through CARES Act; and stated that the department will be regularly monitoring expenses and updating the Board members weekly so that proper planning can occur if services extend into 2021.

The Board members concurred with Mr. McAleer's recommendation to change the end date to 12/31/2020.

Michael Chambers motioned to amend the item to change the end date to 12/31/2020; Nan Baker seconded.

Michael Chambers motioned to conditionally approve the item until the vendor's registration with the Office of the Inspector General could be confirmed; Nan Baker seconded. Item BC2020-542 was conditionally approved by unanimous vote, as amended.

Scope of Work Summary:

The Cuyahoga County Common Pleas Court received a grant award of \$25,000.00 from the Ohio Supreme Court's Civil Justice Program Fund to augment the services of its Resource Center by implementing a Consumer Debt Defense Program. The purpose of the program is to empower low income and self-represented litigants to break the cycle of debt-related litigation by accessing free legal services while maintaining active involvement in the judicial process.

The Consumer Debt Defense Program will provide self-represented litigants who visit its Resource Center with direct legal assistance from Legal Aid Society of Cleveland attorneys to address one of their most pressing civil needs—debt collection litigation. Since the Legal Aid attorneys cannot serve all self-represented litigants, user-friendly brochures and legal process mapping guides will also be created to address their most prevalent debt collection concerns.

Utilization of Civil Justice Program Funds will support the Consumer Debt Defense Program in three ways. First, funds will augment the Cuyahoga County Common Pleas Court's capacity to serve approximately 60 self-represented litigants with direct legal assistance from Legal Aid Society of Cleveland attorneys. Second, direct legal assistance will go a long way in moving these self-represented litigants toward resolving their debt collection issues. Third, the self-represented litigants will not only have access to supplementary educational materials at the Resource Center but may also benefit from additional services offered by the Legal Aid Society of Cleveland. Other organizations will support the program and include the Cleveland Metropolitan Bar Association and the Cleveland-Marshall College of Law.
