Scope of Work Summary

County Council requesting approval of a 2-year grant with Milestones Autism Resources for the anticipated cost of \$100,000.

If the Project is not new to the County List the Prior Board Approval Number or Resolution Number. R2019-0224

The anticipated start-completion dates are 01/01/2020-12/31/2021.

Online Resources: Milestones' Online Resource Center is home to more than 1,300 resources that address topics such as independent living; financial planning; respite; safety and wandering; recreation; social skills; education and scholarships; art, music, and occupational therapies; nutrition; technology; transportation; and more. Approximately 63,000 unique visitors access the site each year.

Autism Helpdesk: The no-cost Helpdesk guides family members to vital autism services and providers. From the parent in crisis who needs an immediate doctor referral to one who is looking for a social opportunity for their child, the Helpdesk is the first call for personalized assistance. Approximately 600 people contact the Helpdesk each year.

Annual Conference: Milestones' annual multi-day conference brings together more than 1,000 parents, professionals, and self-advocates to share evidence-based practical strategies, learn about best practices, and network with the autism community. Attendees have the opportunity to hear from nationally known keynote speakers and engage in more than 90 educational workshops focusing on field-tested ideas.

Consultation and Training Services: Milestones provides fee-based consultations to families needing more personalized guidance. Milestones also provides customized trainings to school districts, agencies, and professional organizations to ensure that they have the best practices and tools needed to effectively serve those with autism. Approximately 1,550 people attend agency trainings each year.

Teen and Adult Services: Milestones' fee-based services for teens and adults focus on transition planning and creating improved outcomes for life after high school. Whether an individual is college-bound or is pursuing employment, Milestones can provide recommendations to help the Individualized Education Program team, family, and student reach their goals. Beyond the transition years, Milestones helps families and individuals build an adult team, create a plan, access employment support, and integrate into the community.

The primary goals of the project are to achieve these goals, the primary objective is to operate a no-cost Helpdesk to provide support, information, and referrals to those affected by autism. Milestones has established the following outcome measures between January 1-December 31, 2020:

Milestones' Helpdesk will provide tailored advice, resources, and referrals to a minimum of 660 callers (a 10% increase over current numbers).

100% of Helpdesk clients will be provided with clear next steps, appropriate and helpful resources and referrals, and knowledge about where to turn as challenges arise.

85% of Helpdesk clients will indicate that they: a) are satisfied with their experience; b) received a plan of action and resources that are appropriate and helpful; and c) know where to turn as challenges arise.

Procurement

The procurement method for this project was grant agreement. The total value of the 2-year grant agreement is \$100,000.

The project County Council approved funding for this 2-year grant with Milestones Autism Resources in the 2020/2021 budget.

Funding

The project is funded 100% by the Health and Human Services Levy.

The schedule of payments is \$50,000 annually.
