I – CALL TO ORDER

The meeting was called to order at 11:01 a.m.

II – REVIEW MINUTES – 1/4/2021

Michael Chambers motioned to approve the minutes from the January 4, 2021 meeting; Dale Miller seconded. The minutes were approved by unanimous vote, as written.

III – PUBLIC COMMENT**

There was no public comment.

Robert Coury, Michelle Henry, Donna Kaleal and Tanisha Gates, Sheriff's Department, presented.

Nan Baker asked for clarification on the response to the advanced questions as to why transferring inmates to the City of Solon is less costly that utilizing the County's downtown facility; and asked for confirmation that the Bedford Heights facility is currently non-operational and is no longer an option.

Dale Miller asked for confirmation that the per diem rate paid by the City of Cleveland under the current agreement is approximately \$100.00 per inmate, while the final per diem rate is actually between \$175.00

- \$180.00 per inmate at the downtown jail; asked if the rate for the City of Cleveland only increases by a small percentage annually; asked if costs increase incrementally as the jail population increases and how do those incremental changes impact the \$175.00 - \$180.00 rate; and asked how many inmates are currently being housed on behalf of the City of Cleveland.

Trevor McAleer commented that prior to the COVID-19 pandemic, there were approximately 100 prisoners under the agreement with the City of Cleveland; cautioned Mr. Coury's use of the term "artificial numbers" when referring to the actual per diem rate of \$175.00 - \$180.00 per inmate, as he believes the numbers have remained consistent and will not increase in the next 6 months or longer; said that \$180.00 per day is a real number that reflects the 2020 actual costs per inmate and could possibly remain the same for several more years; and commented that the overhead costs will decrease if a new jail is built.

Michael Chambers motioned to approve the item; Trevor McAleer seconded. Item BC2021-12 was approved by unanimous vote.

A. Scope of Work Summary

Family and Children First Council requesting approval of An Alternative Procurement with various vendors for the anticipated cost of not-to-exceed \$375,000.00. The state allocated a local funding amount to each FCFC through the local DCFS agencies.

The anticipated start-completion dates are 07/01/20 to the funds are expended.

The primary goals of the project are (list 2 to 3 goals).

•the state is providing supports to parents and not relinquish custody to receive services through local funds

• to allow various vendors to be paid through the alternative procurement method

B. Procurement

The state authorized this funding to allow parents to prevent custody relinquishments. FCFC has MOU's with the Division of Children and Family Services, ADAMHS Board, Board of Developmental Disabilities, and Juvenile Court. FCFCs have an agreement with the Ohio Department of Medicaid to pay for the approved applications for services which was approved in item BC2020-432.

C. Contractor and Project Information various providers

The project is located in all Council Districts of Cuyahoga County.

D. Project Status and Planning The project reoccurs annually.

Governor DeWine created a budget line item to the 2020-2021 Multi System Youth. This budget line also included local funding funneled through the local DCFS offices.

Applications will be submitted to the Multi System vetting team. Once the team has approved or denied the application, the services will be paid for through the FCFC directly to the vendor or as a reimbursement to one of the systems through the MOU.

Reason for late submittal - The MSY local funds were given to us late in the year. Our Budget Officer, resigned in October 2020 and was the only person who was assigned to complete MSY activities in Infor. I had to request to be assigned to the MSY Requestor in Infor which took several weeks.

The funding runs a state fiscal year, July 1 to June 30. We received the funding in September 29, 2020. We can not apply for the alternative procurement until the funding is actually allocated. Additionally, there was hesitation in splitting the amount into years because it's hard to truly estimate what true amounts are requested in the first year of funding. A second request would have been needed if too little or too much been requested. A request was made to the fiscal office to create a rolling fund for our office to alleviate this problem which will begin in the beginning of 2021.

For both items, there was a budget error I received when created the requisitions stating we were over budget for the amounts, even with splitting the years. It took several months to correct the problem with OBM and the fiscal office.

The Allocation Acceptance Letter was approved in item CON2020-48 on 8/10/2020.

The applications for the youth and families are received from the Board of DD, Bright Beginnings, Juvenile Court, DCFS, and ADAMHS Bd and the wraparound service must be included on an IFSCP from their respective agencies. The wraparound service is based on the needs of the child(ren) and their families, hence the need for the Alternative Procurement. The families are able to choose the service and vendor based on their child(ren) specific need.

This item is to request an Alternative Procurement method to pay the vendors and invoices as has been done in previous years. The invoices and vendors are vetted through the FCFC office according to the County's procedures, approved by the OPD office via Infor. This exemption from being reviewing by the BOC weekly allows for a more timely payment process to the vendors and expedited services to the youth and families.

Reason for late submittal - The funding runs a state fiscal year, July 1 to June 30. We received the funding in September 29, 2020. We cannot apply for the alternative procurement until the funding is actually allocated. Additionally, there was hesitation in splitting the amount into years because it's hard to truly estimate what true amounts are requested in the first year of funding. A second request would have been needed if too little or too much been requested. A request was made to the fiscal office to create a rolling fund for our office to alleviate this problem which will begin in the beginning of 2021.

There was a budget error I received when created the requisitions stating we were over budget for the amounts, even with splitting the years. It took several months to correct the problem with OBM and the fiscal office.

The funding is 75% state funding and 25% federal funding for mental health services specifically.

Office of Homeless Services – RQ# 3912 – 2020 – ALTERNATIVE PROCUREMENT PROCESS – Emergency Shelter for Single Adult Men.

Request to amend Board of Control approval BC2020-581 to change the end date to 9/3/2022 to coincide with a federal grant period, and to increase the total value of the alternative procurement to \$3,958,232, after grant funding through the ESG CARES CV2 program was awarded to OHS.
