**Communications**

**Emergency Management**

Mark Christie reported more PA guidance for reopening. EMAP accreditation coming to an end. County EOC will not activate for NFL draft but support Cleveland EOC virtually or in person. BOE will use EOC for May 4 elections – Wolstein Center on going operation with minimal support from county. Three section of Hazmat training on June 8,9, and 10 in Brecksville. Bryan Kloss reported 17.1 million pieces of PPE pushed out during pandemic. Next push is schools and hospital system. RTF is progressing and will launch course this summer. Questions from Beth Gatlin – Mark can you give update on FEMA cost recovery? Mark replied on 4/12/2021 FEMA will start accepting applications for cost recovery program for individuals not government agencies or companies. Alex Pellom added – RTF reimbursement money coming from PSJS spent on backfill and overtime. Question from Bruce Elliot has the County or Cleveland had any discussions about repercussions of the Derrick Chauvin ruling? Fred Szabo replied that Cleveland has an IAP and is on standby and monitoring events but will activate a plan. Mark deferred to Mike Herb who replied will continue to monitor.
