BACKGROUND

Every ten years, the United States conducts a nationwide census, determining the population of our cities, counties, and states. The Cuyahoga County Charter requires that "immediately following the decennial Federal census" there be appointed a five-member Council Districting Commission. This Commission must prepare and certify to the Cuyahoga County Board of Elections a detailed apportionment of the 11 County Council Districts in accordance with specific, delineated Charter provisions. The five-member Commission shall be appointed by the County Council and must release its findings to the Cuyahoga County Board of Elections within one-hundred-and-twenty (120) days of appointment.

TIMING OF RE-DISTRICTING OPERATIONS

The federal government has indicated that preliminary census numbers will be issued in mid-August of 2021, with the final census numbers anticipated by the end of September of 2021. As noted, the County Charter establishes two important timing requirements regarding the creation of the Commission and the issuance of the Council boundaries:

- The Council must appoint the Commission "immediately" after the issuance of the decennial census; and
- The final report issued by the Commission must be released within one-hundred-and-twenty (120) days of the Commission's appointment.

Additionally, six of the eleven council districts (odd-numbered districts) will be up for election in November of 2022. With the primary election schedule, and filing deadlines rapidly advancing, it is imperative that the County Council move promptly to meet the required dates. The retention of a qualified consultant will greatly assist in completing these tasks and complying with all the required mandates.

The primary goals of the project are:

The goal of the re-districting process is to assess the need for new council district boundaries to comply with the provisions found in federal and state law, as well as the requirements of our County Charter. These mandates include:

- All districts shall be of substantially equal population;
- All districts shall be compact and composed of contiguous territory;
- Preference shall be given to combining existing areas of governmental units;
- In determining district boundaries, consideration shall be given to broaden the opportunities for historically under-represented and minority communities to elect representatives to the County Council;

- Any other criteria for the Commission shall be guided by principles to achieve a
 government that is effective, efficient, accountable, responsive, and representative of the
 County, as a whole; and
- Any criteria utilized in determining district boundaries, must not conflict with the Constitution of the United States, the Constitution of the State of Ohio, and all applicable federal and state laws.

Redistricting is mandated by County Charter Section 3.04, as well as applicable provisions found in federal and state law. The Council Districting Commission must be formed "immediately" after the conclusion of the federal decennial census. It is anticipated that the census figures will be finalized in August of 2021. Per Charter Section 3.04, all work of the Commission must be completed within 120 days of the appointment of the Commission members.

PREVIOUS RE-DISTRICTING ACTIVITIES

Since the advent of the Executive/Council form of County government, Cuyahoga County has had only one opportunity to appoint a Council Districting Commission. In 2011, following the release of the decennial census, Cuyahoga County appointed the initial Redistricting Commission. To assist the Commission in meeting its obligations mandated by the County's Charter, Council issued a Request for Qualifications (RFQ) to retain the services of a professional consultant. The hired consultant had expertise in the re-districting process, and assured compliance with all charter provisions, and all applicable legal provisions.

SPECIFICATIONS OF RE-DISTRICTING RFQ

As noted, the County has retained consulting services for the previous re-districting process. The RFQ for this iteration will be held open for two weeks (14 days). The RFQ will be issued to all individuals and entities who responded to the initial re-districting process as well as all others who have inquired about the county's re-districting process. The RFP will also be listed on the Council's website with a media advisory going out to the local media that Council has issued the RFP. Additionally, Council will contact the Department of Purchasing to determine what entities are on file that may meet the criteria for service as a consultant in this process. All submissions will be made via electronic mail. Upon receipt, a panel will be established to review the submissions and select the preferred consultant.

Due to the restricted time frame for completion, as well as the very specific nature of the work to be performed in this matter, the Council is seeking this Alternate Procurement process.

Project Status and Planning

The appointment of the Commission only occurs after the conclusion of the federal decennial census. This process will not recur until 2031. As noted above, this is the second iteration of the County's redistricting process, after the initial process in 2011. The Commission is mandated to begin its work immediately after the decennial census is finalized, and all the work must be completed within one-hundred and twenty (120) days of the confirmation of the Commission members.

Following the below RFP process will save the County 2-3 weeks in the RFP process by issuing the RFP earlier, scoring, then allowing pricing changes if needed before making a final selection. The Department has consulted with the County's Benefits Consultant who agrees that this is the best process to ensure competitive, accurate proposals.

Modified RFP Process Steps:

- 1. Issue RFP Solicitation for 30 days;
- 2. Upon closing, department scores RFP with preliminary pricing;
- 3. Accurate claim data made available to vendors September 10-15;
- 4. Vendors given a week to evaluate and submit revised pricing only to Department;
- 5. Department scores and finalizes RFP award;
- 6. Department follows standard RFP contract award process with Council approval required.

The primary goal of the project is to maintain Stop Loss coverage for the County, which mitigates risk from catastrophic and extraordinarily high healthcare claims. This alternate procurement is the Department's best efforts to process this RFP and resulting contract on time due to the nature of Stop Loss coverage and the data required for estimates.
