4. GRANTS UPDATE

Larry Tafe provided a grants update. He commented that the State has released FY 21 grants in the amount of \$600,061. Homeland – Cyber requirement is \$80,000 going to Cyber Security. There is a mandatory minimum amount of \$257,130. \$80,000 going to fight domestic violence. Brad Hanke commented that all radios from the last grant were deployed except Walton Hills and Oakwood. He also commented that he told East Cleveland to reach out to the State for assistance regarding radios that stopped working. Brad Hanke asked Larry Tafe who from the State would handle non-working radios. Larry Tafe commented that the radios are only two years old and should be under warranty. Chief Elliot commented asked if Highland Heights was going to be on the Marcs System. Larry Tafe commented that money from previous grant has been reallocated and the radio vendor received a purchase order on Monday, July 12th, 2021. He also stated that Highland Heights radio and COW machine should be delivered to CVD in August. Email regarding State grant should be out July 14th. Chief Elliot asked when do radio requests have to be submitted. State commented that all requests need to be in by July 23rd. Meetings for all radio requests need to occur between July 22rd and August 6th. Larry Tafe commented that committees will have to meet to vote on projects.

5. EXERCISE/DRILLS FOR COM-L PARTICIPATION

Adam Griffith commented that there will be a real-world activation in EOC on August 3rd.
He also commented that there will be a full-scale Hazmat exercise at Tri-C West and a Mass Casualty exercise at Hopkins International Airport on September 21st.
