Leigh Tucker motioned to approve the minutes from the December 13, 2021 meeting; Joseph Nanni seconded. The minutes were approved by unanimous vote, as written.

Nan Baker asked if a design is created prior to the project commencement then why is there a relatively high cost being assessed for design services after the project has been started; was the anticipated cost budgeted incorrectly in comparison to the needs that were to be met; what will the new total amount of the contract with the new request. Leigh Tucker motioned to approve the item; Joseph Nanni seconded. Item BC2021-742 was approved by unanimous vote.

Dale Miller asked will the County have to incur the cost for the delay claim; if so, approximately how much would the cost be associated with the delay claim; is the blame of the delay being assessed to the County; what is the total value of the contract; what would be the approximate cost of the delay claim. Leigh Tucker motioned to approve the item; Dale Miller seconded. Item BC2021-743 was approved by unanimous vote.

Raymond McDaniel, County Treasurer, presented. Dale Miller asked will this create a delay in sending out the tax bills; why is the vendor unable to honor their initial costs; was there a provision to allow the vendor to assess the additional cost back to the County. Joseph Nanni confirmed that this was not contractual dollar amount but an amount that the vendor could not avoid based on how this item was procured; based on the supply chain issues, how can pricing be stabilized and/or secured to be what was quoted. Nan Baker asked if the vendor applied for pandemic relief to absorb the costs that are being passed to the County; commented that although this project has to be completed, the County must be mindful of all potential costs that could be associated with completing the project. Leigh Tucker motioned to approve the item; Joseph Nanni seconded. Item BC2021-745 was approved by unanimous vote.

Mike Foley, Department of Sustainability, presented. Nan Baker asked how much of the total cost can be reimbursed by the vendor; if any additional costs related to the project will be reimbursable by the vendor; the County should not anticipate to incur any costs associated with this project; outside of any grants, current or future, it is expected that the vendor will reimburse any and all costs associated with this project; it can be assumed that there will be no other pre-developmental costs that will need to be considered; why were certain costs not included in the developer's costs; said that we need to be careful in what is being assessed with this project and what is being asked to be approved due to the understanding of what the vendor is responsible for versus what the County will be responsible for. Joseph Nanni asked how will the County be reimbursed by the vendor for costs associated with this project; it is understood that the County should be benefitting from grants and any other funds related to this project, the funding should not be given to the vendor, who should be absorbing the costs of the project; when can the request for proposal (RFP) be expected. Dale Miller asked regarding the timeframe mentioned previously, is that to assist with developing this project or conducting the RFP process to locate a developer. Leigh Tucker motioned to approve the item; Nichole English seconded. Item BC2021-748 was approved by unanimous vote.
